

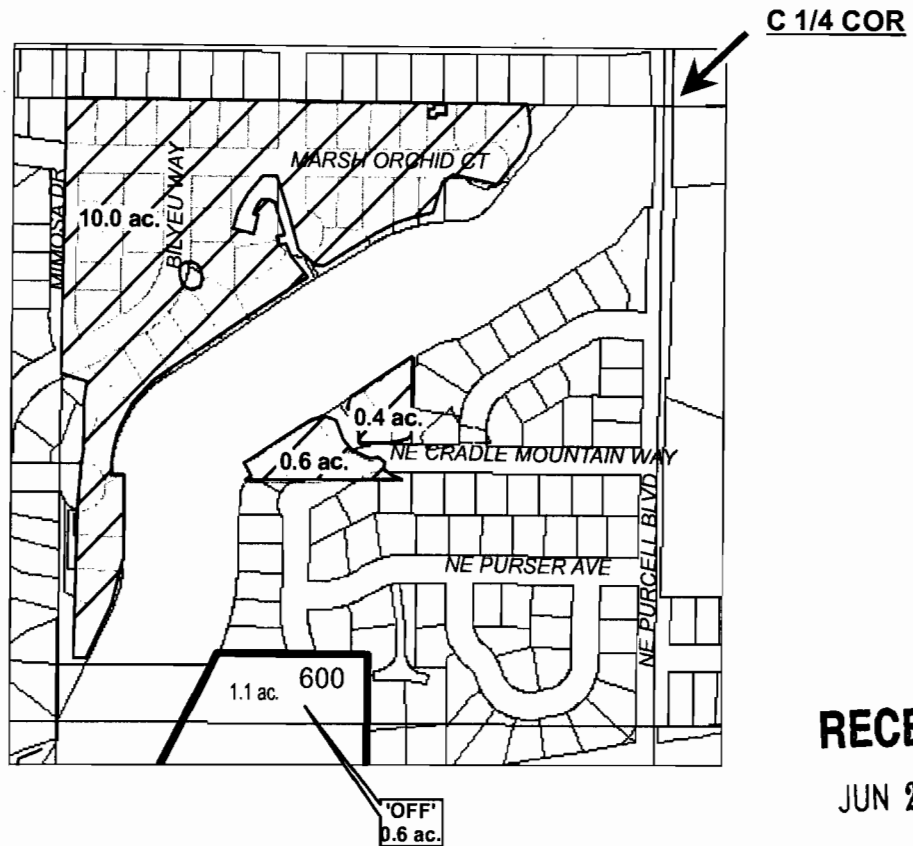
DESCHUTES COUNTY SEC.22 T17S R12E
