The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 5.94 CUBIC FEET PER SECOND, BEING 1.54 cfs from WELL 1, 0.99 cfs from WELL 2, 1.73 cfs from WELL 3, and 1.68 cfs from WELL 4, or its equivalent in case of rotation, measured at the wells.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
