- IV. Enclosed is a map for each proposed change in place of use meeting the standards of OAR Chapter 690, Division 385.
- V. This transfer is identical to district temporary transfers, 2008 T-10611 and 2009 T-10834.
- VI. Under this transfer, the water authorized from well #2 in certificate 82441 will be pumped into the Westland canal as identified on the transfer map at pump 6E, conveyed down the Westland canal and diverted at pump 7A. Approximately 67% of the to ground acres involved in this transfer are for ground water certificate 82441 and the remaining 33% are Westland primary surface water certificate 76715 (with supplemental certificate 79439). The water user and the District will monitor the flow meters to verify that approximately 67% of the water delivered on the to grounds at meter #08-03539-06 is equal to the amount of water that is pumped into Westland canal at pump 6E from Well #2 (meter # 95-740-6), in as close to real time as possible. Water from Well #1 will only be applied to the certificate 82441 acres on the to ground when Westland Irrigation District's primary surface water certificate 76715 and supplemental certificate 79439 are no longer available. The 17.2 acres from certificate 82441 (in the SW NW of section 18) not involved with this temporary transfer will not receive water in 2010 when Westland Irrigation District's surface water primary certificate 76715 and supplemental certificate 79439 are available.
- VII. The water right proposed for transfer is a water right subject to transfer and has not been forfeited for nonuse under ORS 540.610.
- VIII. Each user affected by the proposed transfer has provided written authorization for the transfer and such authorization is on file with the district.
- IX. The district has notified each affected user that the Department may condition or reject the transfer at any time to the extent necessary to avoid injury to an existing water right, and that the use of water on lands from which the water right is transferred (authorized place of use) and at the proposed place of use during the same irrigation season or calendar year may subject both the user and district to civil penalties.
- X. Enclosed is the application fee in the amount of: \$\\$1025.00
