

Additional remarks: Proposed Domestic use is for residence and guest house. Certificate allows 0.106 cfs for 7.7 ac. (0.106/7.7 = 0.0137665). 0.75 acres x 0.0137665 = 0.010325 cfs. Irrigation season is 214 days (4/1 thru 10/31. 0.010325 cfs x 214/365 = 0.006 cfs. 4.5 acre-feet per acre is common in the Rogue Basin for older rights. 0.75 ac. x 4.5 a.f. = 3.38 a.f. per year. ODF&W has removed the concrete dam at the authorized point of diversion.
