### Authority

ORS 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

# **Applicant**

ECHO IRRIGATION DISTRICT 73120 HIGHWAY 207 ECHO, OR 97826

#### **Findings of Fact**

- 1. On April 1, 2010, Echo Irrigation District filed a district transfer application to temporarily change the place of use within the boundaries of the irrigation district under Certificates 80849, 80850, 85124 and Certificate 74896 (as modified by Transfer Application T-6787). The Department assigned the application number T-11051.
- 2. Notice of the application for temporary transfer was published April 13, 2010, pursuant to ORS 540.570 and OAR 690-385-3400. No comments were filed in response to the notice.
- 3. On April 29, 2010, and again on June 10, 2010, Echo Irrigation District amended their application and map to clarify the place of use.
- 4. The portion of the FIRST primary right and its layered supplemental right to be transferred is as follows:

Certificate: 85124, issued in the name of Robert C., Rick L., and Douglas Hale (perfected

under Permit G-4969)

Priority Date: June 8, 1971

Quantity: 0.47 cubic foot per second (cfs)

Use: IRRIGATION of 50.31 acres

Rate & Duty: ONE-EIGHTIETH of one cfs and 3.0 acre-feet per acre for each acre

irrigated during the irrigation season of each year.

- 14. The Department has determined that the proposed additional points of appropriation (Coppinger New Well #1, Ditchen Wells #1 and #2) are all within the same subareas (D and H) of the Stage Gulch Critical Ground Water Area and will all develop the same source of water as the authorized existing wells described in Certificates 80849, 80850 and 85124.
- 15. Pursuant to OAR 690-385-3110, Echo Irrigation District has indicated that water use under existing water rights or water use permits will remain unexercised nor will the water rights or water use permits be transferred during the course of the 2010 irrigation season. (See Findings of Facts #5, #7, and #12.)
- 16. Notice of the application for temporary transfer was published April 13, 2010, pursuant to ORS 540.570 and OAR 690-385-3400. No comments were filed in response to the notice.

- 17. The district temporary transfer application satisfies the criteria of OAR 690-385-3000, contains the information required under OAR 690-385-3200, and includes a map meeting the requirements of OAR 690-385-3300.
- 18. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 19. The proposed changes in place of use would not result in enlargement of the rights.
- 20. The proposed changes would not result in injury to other water rights.

#### **Conclusions of Law**

The temporary changed in place of use and additional points of appropriation as proposed in Transfer Application T-11051 satisfies the requirements of ORS 540.574(3) and 540.570.

# Now, therefore, it is ORDERED:

- 1. The temporary changes proposed in Transfer Application T-11051 are approved.
- 2. The former places of use **shall not** be irrigated as part of these water rights during the 2010 irrigation season.
- 3. The use shall revert to the authorized places of use at the end of the 2010 irrigation season. The authorization to use the additional points of appropriation shall be terminated concurrently.
- 4. The District shall not use water under portions of Certificate 76369 and water use Permit S-54561 at the proposed places of use as described in Findings of Fact #5, #7 and #12 during the 2010 irrigation season. Additionally, the District shall not transfer the portions of the existing water right identified in the above cited findings of fact.
- 5. The right to the use of the water at the temporary place of use authorized by this transfer shall be in accordance with the conditions and limitations contained in Certificates 80849, 80850, 85124, 74896 (as modified by Transfer Application T-6787) and any related decree.
- 6. The amount of water allowed under each of the rights is as follows:

- 7. Before water may be applied to the proposed "TO" lands, the District shall install totalizing flow meters or other measurement systems as approved by the Department at:
  - a) The point of diversion from the Columbia River and all other points of diversion or appropriation, which supply water to the proposed "TO" lands;
  - b) The northern boundary connection of the Echo Irrigation District; and
  - c) All field diversions (center pivots or other method of water delivery) used to apply water to the new lands.
  - Additionally, the meters must be maintained in good working order according to manufacturer's specifications.
- 8. The District shall maintain a complete record of water usage on a monthly basis and shall submit monthly and annual reports to the Watermaster's office in Pendleton. The water use reports shall include recorded monthly water usage measurements from each point of diversion, each point of appropriation (well) the measurement device located at the North Echo Irrigation District boundary connection and for each field diversion (center pivot or other means of application). The reports shall also include dates of measurement and other information as may be requested by the Watermaster. The frequency or timing of the reports may be modified upon a determination by the Department that an alternate frequency is needed or appropriate. The reporting frequency may also be modified after the second full season of use, if requested by the receiving landowner and approved by the Department. The reports may be e-mailed, faxed or mailed.
- 9. The quantity of water diverted at the additional points of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.
- 10. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 11. The use of water on the lands from which the water right is transferred and at the new temporary place of use during the same irrigation season or calendar year is prohibited and may subject the district and landowner to civil penalties.
- 12. The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
- 13. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
- 14. A subsequent application for permanent transfer of Certificates 80849, 80850, 85124 or Permit G-2415 (as modified under transfer application T-6787) shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690,

- Divisions 380 and 385. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.
- 15. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 80849, 80850 and 85124 and Certificate 74896 (as modified under transfer application T-6787).
- 16. Additional measurement and reporting conditions, including, but not limited to, additional measuring sites, general water use information, and the place and nature of water use may be required at the discretion of the Department.
- 17. The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture under ORS 540.610.
- 18. The use of the remaining water rights described by Certificates 80849, 80850 and 85124 and Permit G-2415 (as modified by Transfer Application T-6787) shall continue to be in accordance with the terms and conditions of Certificates 80849, 80850, 85124 and Certificate 74896 (as modified by Transfer Application T-6787).
