

As part of the sale agreement a transfer was to be filed to allow use of water from the domestic well (UMAT 54461) to irrigate 2.73 acres on this tax lot. The authorized well (UMAT 4277) is located in a field some distance south of tax lot 602 and is responsible for irrigating 7.95 acres. The applicant wishes to use the domestic well for the 2.73 acres on tax lot 602 only, as it will be more accessible and convenient. Tax lot 602 is currently up for sale.**

All irrigation from this system is delivered to the land by 3 inch hand lines with 40 feet by 60 feet spacing.**
