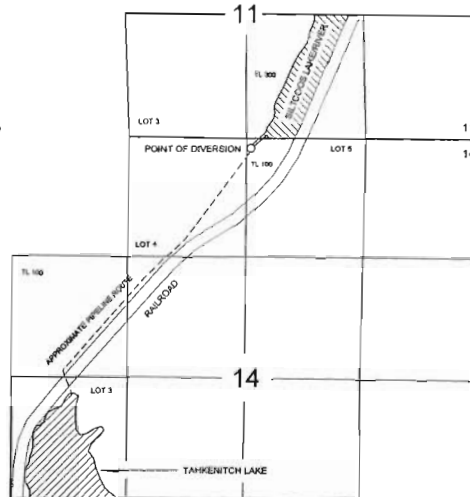

THE DIVERSION FOR THE SILTCOOS RIVER IS LOCATED 100 FEET SOUTH AND 2580 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 14; BEING WITHIN THE NW 1/4 NE 1/4 (LOT 5) OF SECTION 14, TOWNSHIP 20 SOUTH, RANGE 12 WEST, W.M.; DOUGLAS COUNTY.

WATER FROM SILTCOOS LAKE AND RESERVOIR IS A SUPPLEMENTAL SOURCE ONLY. WHEN LEASED, ALL THE WATER FROM SILTCOOS LAKE AND RESERVOIR WILL BE LEASED.

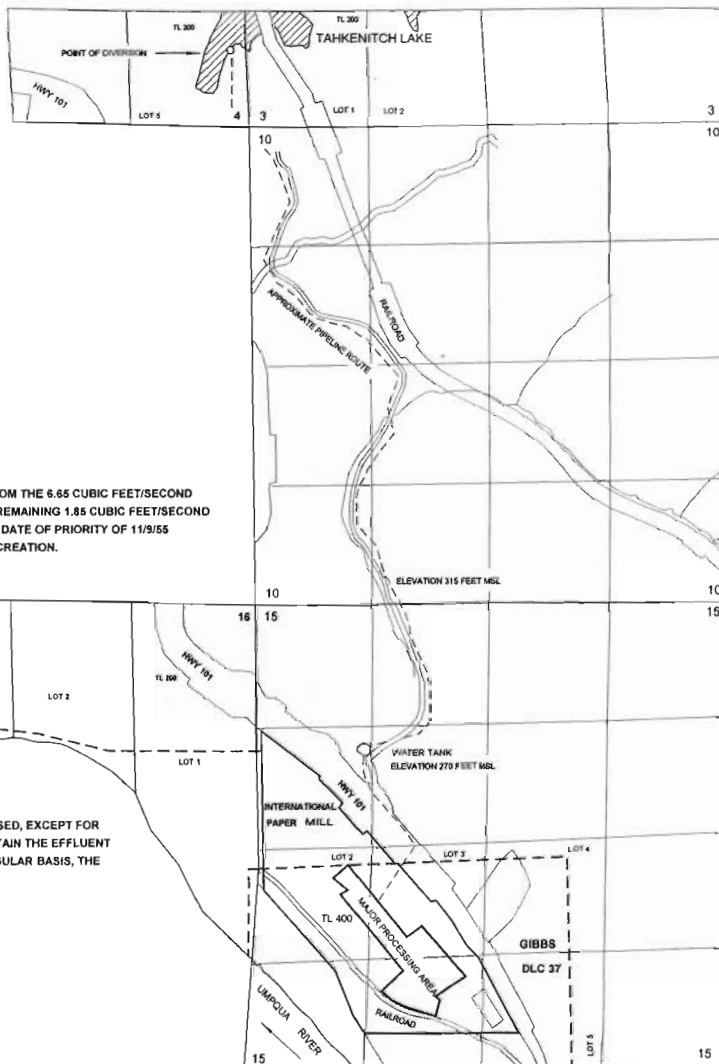

THE TAHKENITCH LAKE POINT OF DIVERSION IS LOCATED 860 FEET NORTH AND 200 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 4; BEING WITHIN THE SE 1/4 SE 1/4 (LOT 5) OF SECTION 4, TOWNSHIP 21 SOUTH, RANGE 12 WEST, W.M.; DOUGLAS COUNTY.



4.8 CUBIC FEET/SECOND WILL BE TAKEN FROM THE 6.65 CUBIC FEET/SECOND UNDER DATE OF PRIORITY OF 3/16/65. THE REMAINING 1.85 CUBIC FEET/SECOND AND THE 19.65 CUBIC FEET/SECOND UNDER DATE OF PRIORITY OF 11/9/55 TO BE LEASED FOR FISH, WILDLIFE AND RECREATION.



ALL USE OF WATER WILL BE DISCONTINUED, WHEN LEASED, EXCEPT FOR 4.8 CUBIC FEET/SECOND WHICH WILL BE USED TO MAINTAIN THE EFFLUENT PIPELINE (OR OCEAN OUTFALL). IF NOT USED ON A REGULAR BASIS, THE LINE WILL FILL WITH SAND AND BE USELESS.

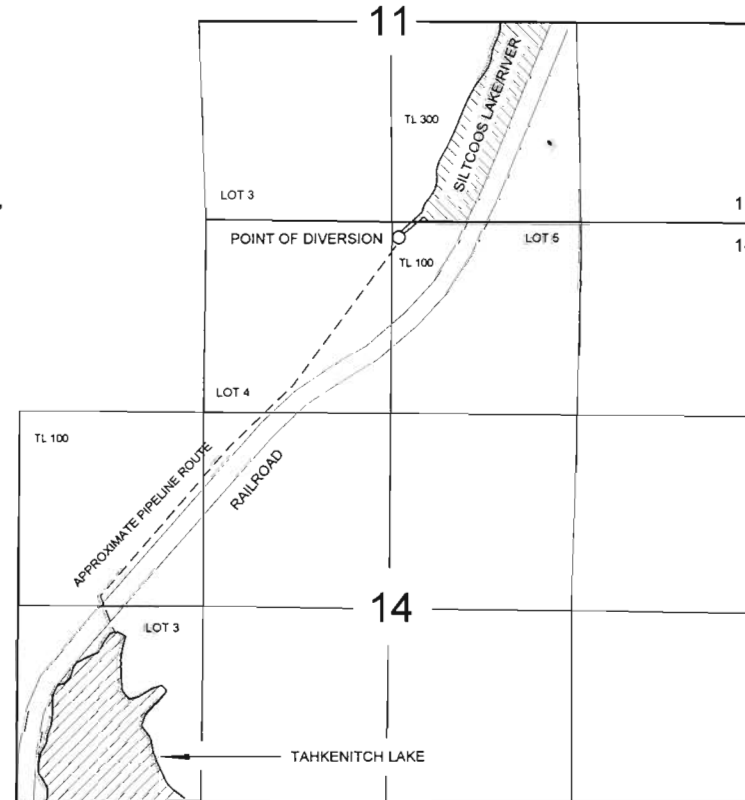

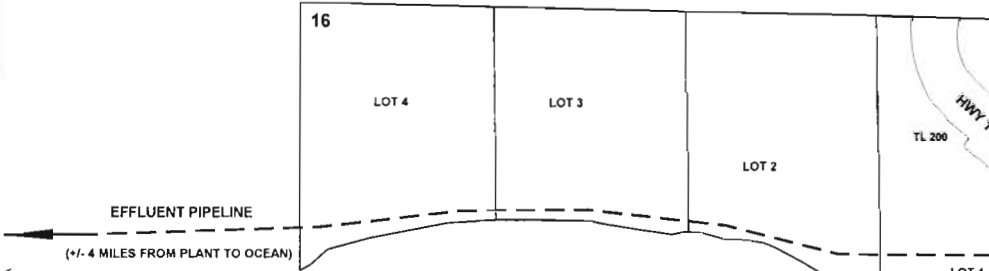

4.8 CUBIC FEET/SECOND WILL BE TAKEN FROM THE 6.65 CUBIC FEET/SECOND UNDER DATE OF PRIORITY OF 3/16/55. THE REMAINING 1.85 CUBIC FEET/SECOND AND THE 19.65 CUBIC FEET/SECOND UNDER DATE OF PRIORITY OF 11/9/55 TO BE LEASED FOR FISH, WILDLIFE AND RECREATION.



ALL USE OF WATER WILL BE DISCONTINUED, WHEN LEASED, EXCEPT FOR 4.8 CUBIC FEET/SECOND WHICH WILL BE USED TO MAINTAIN THE EFFLUENT PIPELINE (OR OCEAN OUTFALL). IF NOT USED ON A REGULAR BASIS, THE LINE WILL FILL WITH SAND AND BE USELESS.
