

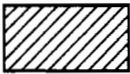

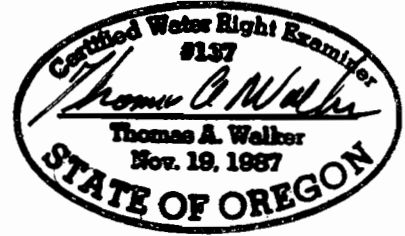


EXISTING IRRIGATION WATER RIGHTS TO BE

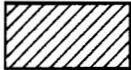

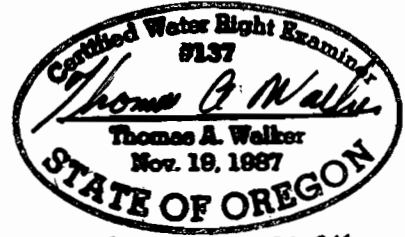

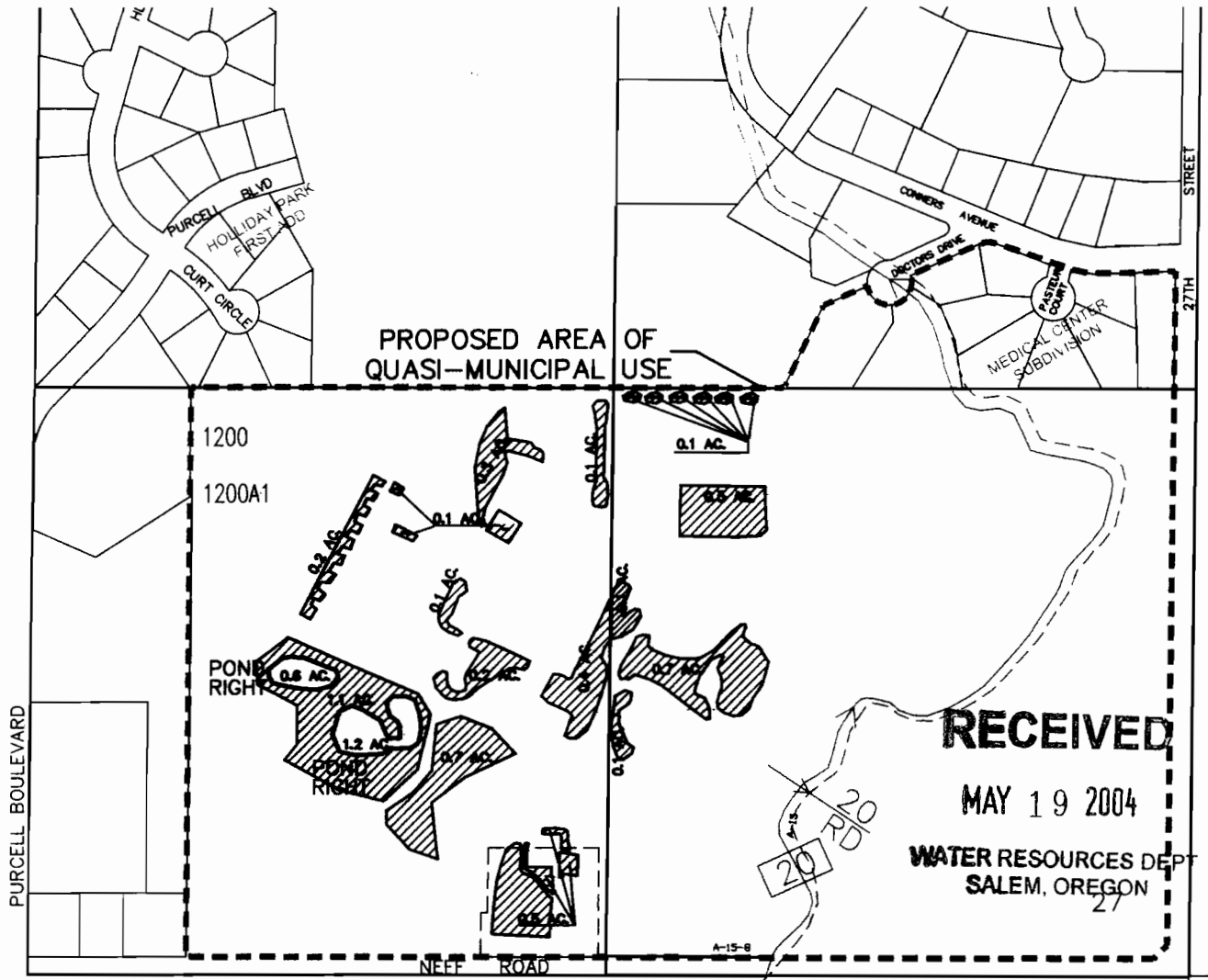
EXISTING IRRIGATION WATER RIGHTS TO BE

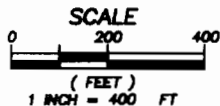
