

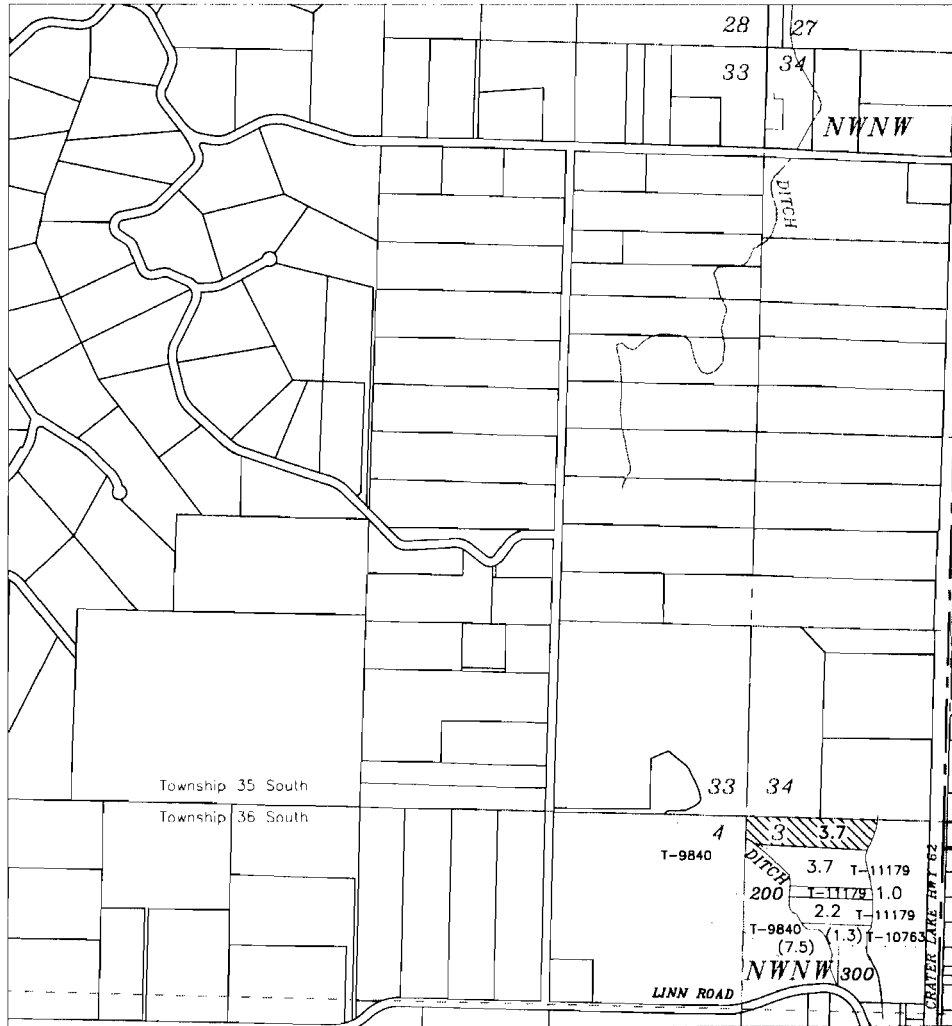

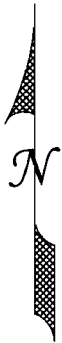
### CHANGE IN PLACE OF USE – MAP 1 OF 4

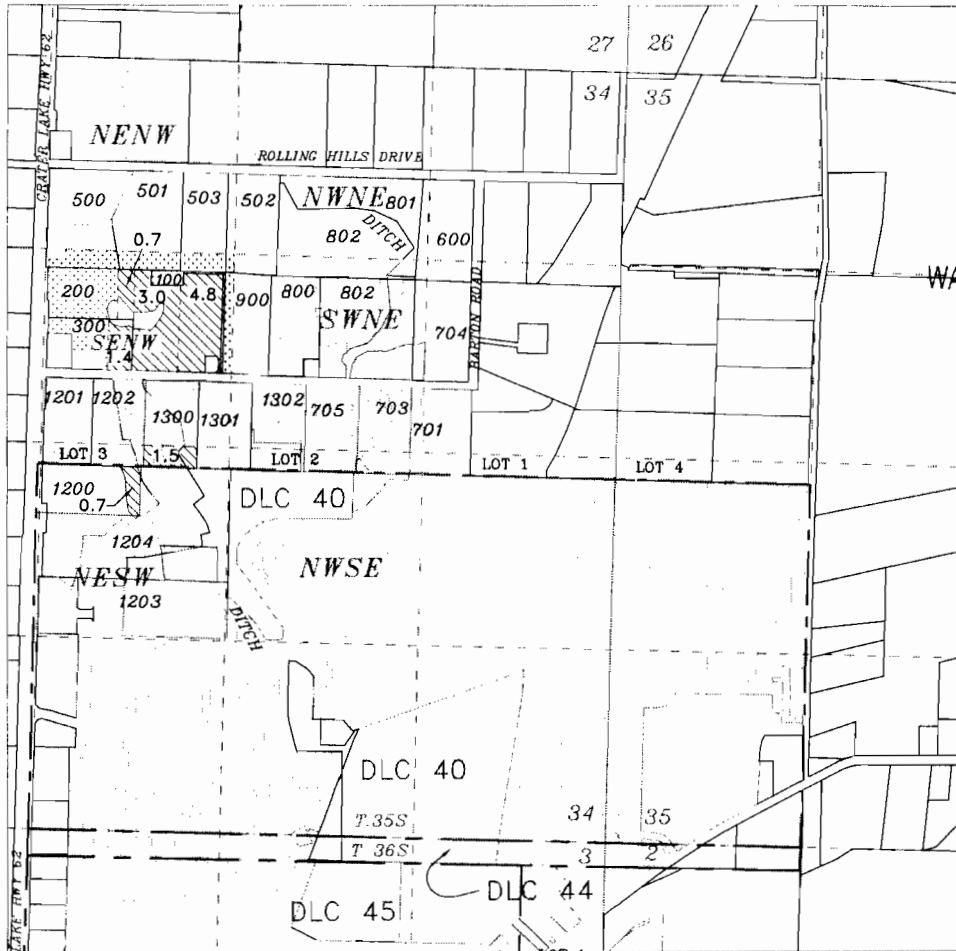

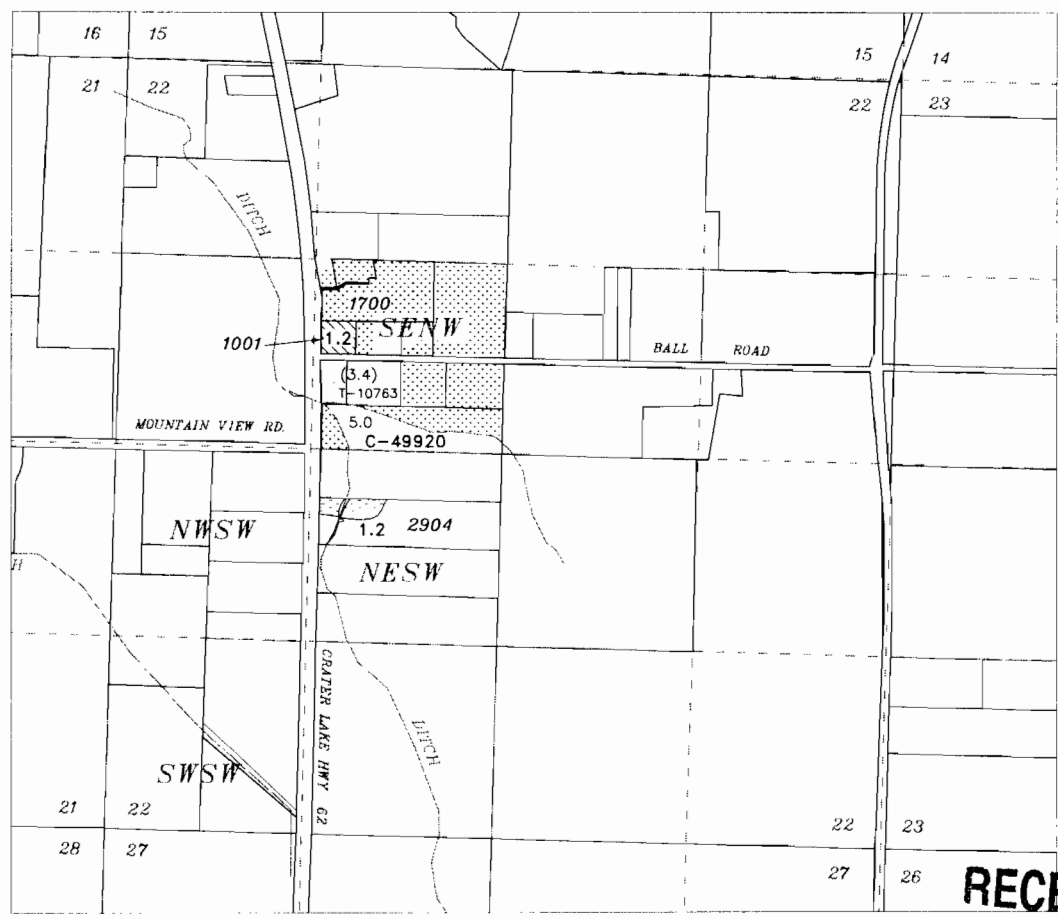

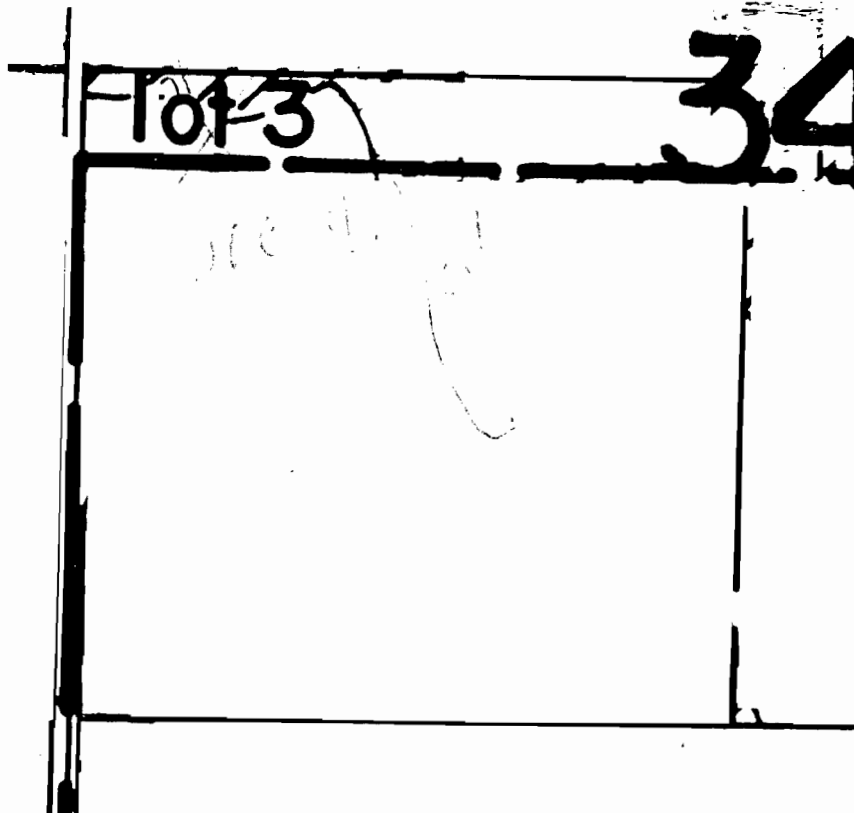
