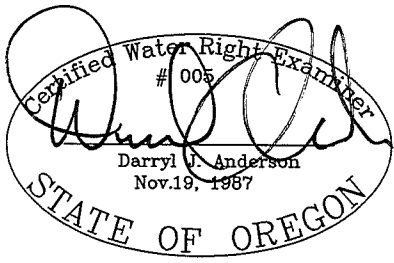


MAP TO ACCOMPANY PERMIT AMENDMENT FOR TOWN OF LAKEVIEW

SECTIONS 15, 22 & 27, TOWNSHIP 39S RANGE 20E, LAKE COUNTY, OREGON



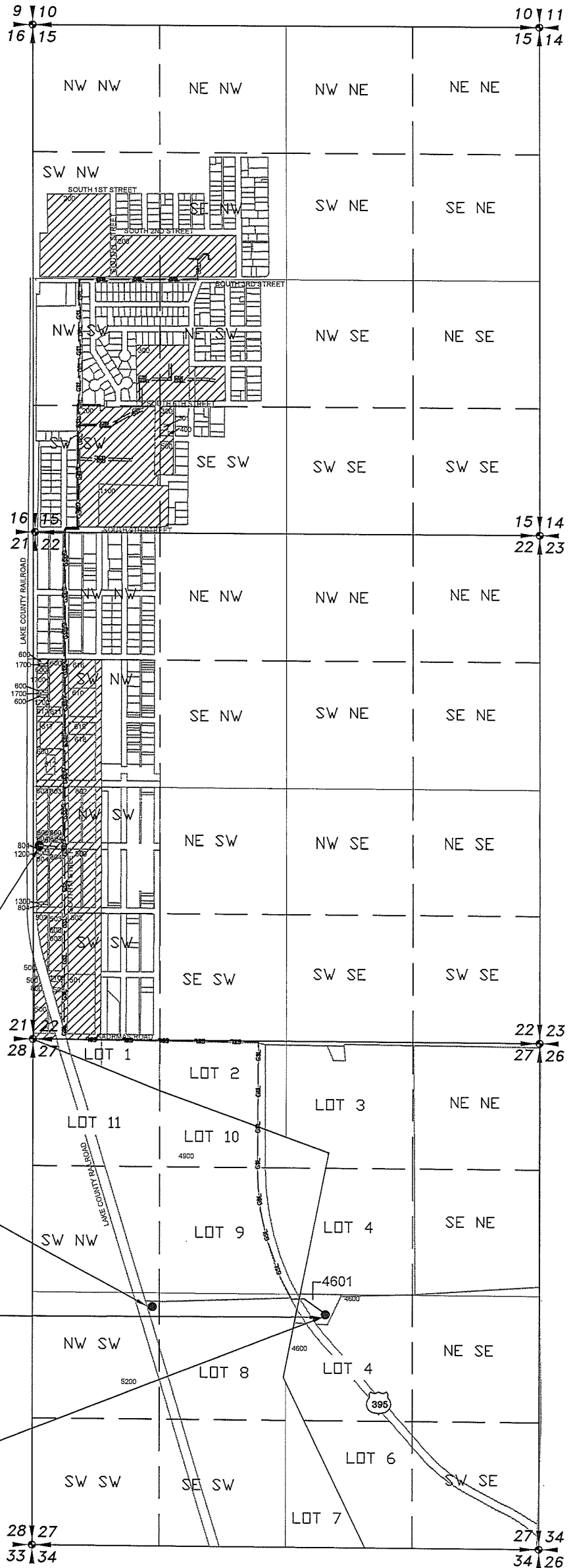

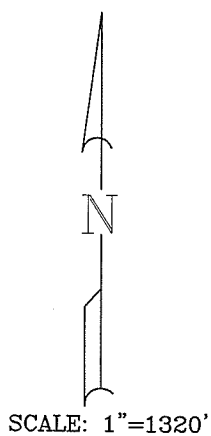

WELL LOG - LAKE 2611



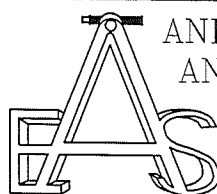
