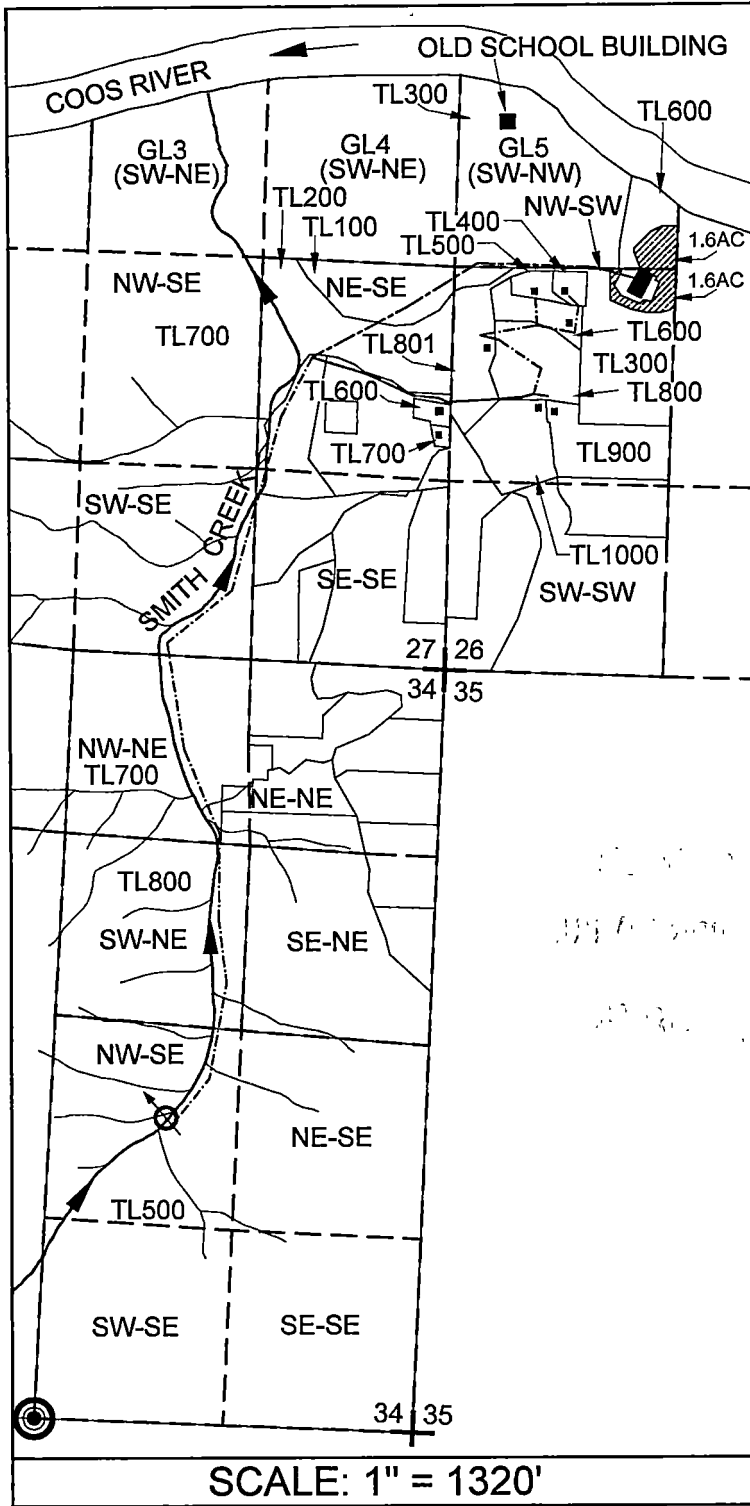


PERMANENT WATER RIGHT TRANSFER MAP

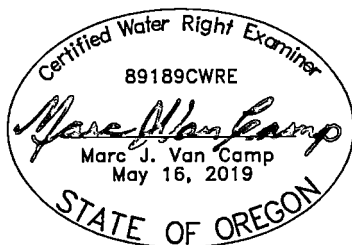
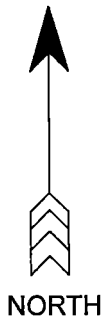
