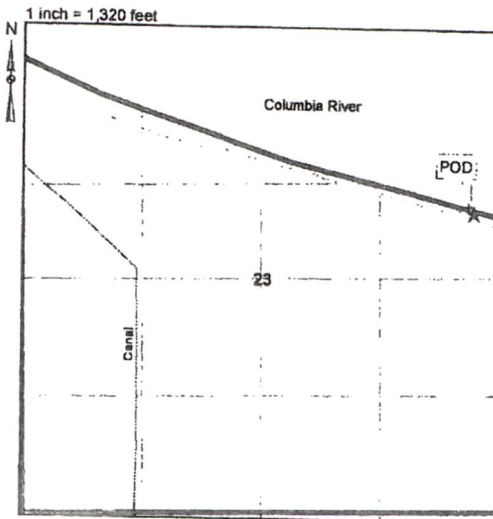
5N 28E W.M Sec. 17, NW/SW: 1900' N and 150' E from the SW Corner of Section 17.
