
The proposed reservoir will be off-channel. The source of water for storage will be overland runoff into the reservoir and runoff collected from a drain tile network. Water will only be diverted for storage during the authorized storage period (point of diversions and drain tiles illustrated on application map). There will be an eightinch minimum diameter outlet pipe for the reservoir, which is anticipated to be installed on the south side of the reservoir. The outlet will drain to an unnamed tributary of Mercer Creek. The application map illustrates the location of the proposed reservoir, proposed point of diversions, the drain tile network, the outlet pipe, and the unnamed tributary of Mercer Creek.



If the diversion involves a dam, use this space below for sketches of the diversion (e.g. cross-section of the dam with its dimensions, dimension and placement of outlet pipe, means of passing live flow outside of the authorized storage season, and means for providing fish passage).

The proposed reservoir is off-channel, therefore there will be no live flow passing through the reservoir to bypass. The anticipated design of the reservoir includes:

- Earthen berms constructed around the northeastern, southern, and southwestern sides of the reservoir.
- The berms will be a maximum height of 9.9 feet at the southern side of the reservoir and will gradually reduce in height along the remaining berm perimeter.
- The interior of the reservoir will be excavated to provide an average depth of 22 feet.
- The surface area of the reservoir will be approximately 0.3 acre
- There will be 1 foot of freeboard at the berm when the reservoir is full.
- There will be an 8-inch minimum diameter outlet pipe for the reservoir (see application map).

of water diversion then the applicant should be advised that a fish screen consistent with screening criteria will be required. ☐ This proposed pond or reservoir contemplates impounding water in the Columbia Basin above Bonneville Dam. ODFW has determined that additional diversions of water in this area pose a significant detrimental impact to existing fishery resources during the period April 15 through September 30.

ESA-listed fish (winter steelhead, Coho salmon), and sensitive species (Coastal Cutthroat Trout), may be present in Mercer Creek and the Tualatin River during the period of impact. Instream flows to fulfill MF174 and or MF175 for aquatic life are not being met partially or wholly during the period of impact. Based on parameters assessed by ODFW, instream flows are currently below those essential to support the biological needs of an existing fishery resource June -November.

Through consultation with DEQ, ODFW has identified a water quality impairment for Dissolved oxygen, pH and chlorophyll on the Tualatin River with a critical period of late summer to early fall. Also, the proposed pond would be located in the Tualatin River basin and subject to the Tualatin River Temperature TMDL which identifies the critical period for water temperatures as June 1-October 31. Low dissolved oxygen and high stream temperatures can be directly lethal to aquatic life but may also have sublethal effects on growth and development during different life stages, as well as the swimming, feeding and reproductive ability of juveniles and adults.

Because of these reasons, the proposed use will diminish water quality, physical habitat, and/or alter the flow regime to which fish are naturally adapted. These changes will negatively affect their distribution, productivity, and abundance. Therefore, a further reduction in flow or alteration of habitat from the proposed use would result in a significant detrimental impact to an existing fishery resource without appropriate conditions and/or mitigation.

Water is only available to support the quality and quantity of biologically necessary flows at the POD and/or downstream during December - May. ODFW recommends the storage season be restricted to coincide with this period or the proposed use be mitigated prior to issuance of a Proposed Final Order for any use outside of this period. Without appropriate mitigation and/or conditions, a further reduction in flow or alteration of habitat (including the impairment of water quality during June - October) from the proposed water use during June - Novemebr will result in a significant detrimental impact to an existing fishery resource. Mitigation is often complicated, time consuming, and expensive, and may include, but is not limited to, actions such as replacing the proposed amount of water through purchasing or transferring an existing water right. If the applicant chooses to pursue mitigation after application submittal to WRD, ODFW will provide appropriate conditions and a Mitigation Obligation consistent with the goals and standards of OAR 635-415-0025 (ODFW Habitat Mitigation Recommendations) to compensate for any potential impact from the proposed use. The permittee shall protect riparian areas, including through irrigation practices and the management of any livestock, allowing site capable vegetation to establish and grow along streams, while providing the following functions: shade (on perennial and some intermittent streams), bank stability, and infiltration or filtration of overland runoff.

The use may be restricted if the quality of source stream or downstream waters decrease to the point that those waters no longer meet existing state or federal water quality standards.





The planning official may choose to complete the form while you wait, or return the receipt stub to you. Applications received by WRD without the Land Use Form or the receipt stub will be returned to you. Please be aware that your application will not be approved without land use approval.

### This form is NOT required if:

- 1) Water is to be diverted, conveyed, and/or used only on federal lands; OR
- 2) The application is for a water right transfer, allocation of conserved water, exchange, permit amendment, or ground water registration modification, and all of the following apply:
  - a) The existing and proposed water use is located entirely within lands zoned for exclusive farm-use or within an irrigation district;
  - b) The application involves a change in place of use only;
  - c) The change does not involve the placement or modification of structures, including but not limited to water diversion, impoundment, distribution facilities, water wells and well houses; and
  - d) The application involves irrigation water uses only.

## NOTE TO LOCAL GOVERNMENTS

The person presenting the attached Land Use Information Form is applying for or modifying a water right. The Water Resources Department (WRD) requires its applicants to obtain land-use information to be sure the water rights do not result in land uses that are incompatible with your comprehensive plan. You will receive notice once the applicant formally submits his or her request to the WRD. The notice will give more information about WRD's water rights process and provide additional comment opportunities. You will have 30 days from the date of the notice to complete the land-use form and return it to the WRD. If no land-use information is received from you within that 30-day period, the WRD may presume the land use associated with the proposed water right is compatible with your comprehensive plan.
