Legal Description

OWRD

The Southeast quarter of the Northwest quarter, excepting therefrom the Westerly 580 feet in Section 8, Township 27 South, Range 2 West, Willamette Meridian, Douglas County, Oregon.

Also, the Northeast quarter of the Southwest quarter, excepting therefrom the Westerly 580 feet and also excepting therefrom that part which lies South of Little River in Section 8, Township 27 South, Range 2 West, Willamette Meridian, Douglas County, Oregon.

EXCEPT: Beginning at a point on the Westerly boundary of that certain tract conveyed by Dimmick to Withers by deed recorded in Volume 292, Instrument No. 275506, Deed Records of Douglas County, Oregon, which point is also on the south side of the Little River Road; thence Easterly, along the south side of Little River Road, a distance of 350 feet to a point; thence Southerly and parallel with the westerly boundary of said Dimmick-Withers Tract to Little River; thence Westerly, along the northerly bank of Little River to the westerly boundary of said tract; thence Northerly to the point of beginning.
