Summary: The Final Order approving Application S-89206 is modified to include the correct irrigation season and the appropriate duty for irrigation.

Authority

This order is issued pursuant to Oregon Administrative Rule (OAR) 137-004-0080.

FINDINGS OF FACT

The findings of fact in the October 4, 2022, Final Order are incorporated herein with the following modifications and additions.

- 1. On October 4, 2022, a Final Order approving Application S-89206 and Permit S-55400 was issued.
- 2. On November 4, 2022, the Department received a Petition for Reconsideration from Tobias Hatfield (applicant).
- 3. On November 14, 2022, the Department notified Tobias Hatfield that the order was being reconsidered.
- 4. During the period of reconsideration, the applicant agreed to:
 - a. Correcting the period of use for supplemental irrigation to April 1 through October 31.
 - Modifying the "not to exceed" duty for irrigation from 2.5 acre-feet (AF) per acre to 4.5 AF per acre.
- 5. Based on a review of the application file, the Department finds that the changes to the Permit described in Finding of Fact #4 are needed.
- 6. By agreement of the applicant on November 16, 2022, a new Permit will be issued.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than contested case. This order is subject to judicial review under ORS 536.075 and ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This Final Order and Permit supersede the October 4, 2022 Final Order and Permit S-55400, which are of no further force or effect.
