Hanel Development Group is the owner of the Water rights and Storage permit on the above referenced certificates. The previous water use was for Log Deck Sprinkling and Fire Prevention.

The past use of the property was for a Lumber Mill operation which included log storage, processing, and shipping of lumber products. The sawmill operation is no longer in operation, and the property is in the process of converting to an industrial park.

The local utility provider is unable to furnish the required amount of water to meet the Fire standard minimums for an industrial building. We wish to convert the use of the water rights and storage from a "specific industrial use" to a "general industrial use", one of which would still be for fire suppression.

The change is needed because the timber industry has been dramatically reduced in the area, and the property, being zoned M-1 heavy industrial, is one of the few places in the Hood River Valley that can support major industry. The development of the property is dependent upon the conversion of the water use.

The water has been and continues to be used for industrial uses to date. Champion Building Products was the previous owner of the property & owned the property at the time of the original filing.


