This permit allowed use of Crooked River for irrigation of 124.0 acres. It had a C-date of 1985.

Ralph did a final proof February 10, 1998. According to his report he reviewed NUID maps in their office, and then did drive by inspections. He found 56.2 acres irrigated.

Subsequently, district permanent transfers have eliminated 15.1 acres; leaving 41.1 acres. Note, there may be other district transfers eliminating more. The records may not be complete.

I suggest we contact NUID and offer them the opportunity to complete the final proof survey. They could use district maps, meeting our standards, for the final proof maps. And provide information necessary to make proof in a report. This would be similar to what they do now for district permanent transfers.

I also suggest the district search their records to insure that are not other district transfers which cancelled portions of this permit.

I would further suggest that they request an extension of time to the present. Then they could include whatever acres are needed, up to 108.9 acres (124.0 - 15.1). Irrigation districts typically have users that irrigate more land than is allowed by the rights and transfers. This would provide the district an opportunity to get a right for the over acreages. This is allowed by ORS 537.252.

This is a win/win. The Department gets a final proof survey completed and it gets taken out of our workload. The District gets a right for any over acreage (up to the limits of the permits) they may have.

Transfer Review Criteria (OAR 690-385-5000)

10. The district permanent transfer application satisfies the criteria of OAR 690-385-4000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.

- 11. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 12. The proposed change in place of use would not result in enlargement of the rights.
- 13. The proposed change in place of use would not result in injury to other water rights.
- 14. The application was not filed prior to the end of the calendar year in which the changes occur as required under ORS 540.580(2). However, the District had notified the Department of the proposed changes in accordance with ORS 540.580(3). The Department's review of the noticed changes found they caused no injury. Having found no injury, the Department was not required to order the District to cease delivery of water or mitigate injury as authorized by ORS 540.580(5). Although the filing date of the application represents a failure to comply with statutory criteria, the late filing does not warrant issuance of notice of violation nor does it produce measurable or irreparable harm to the use of the state's water resources and the public interest.

Conclusions of Law

The proposed changes in place of use in Transfer Application T-10765 satisfy the requirements of ORS 540.574(3) and 540.580, with the exception that the application was not received prior to the end of the calendar year in which a change in place of use occurs as required under ORS 540.580(2). See Finding of Fact #14.

Now, therefore, it is ORDERED:

- 6. A Claim of Beneficial Use shall be submitted by the applicant to the Department by October 1, 2011.
- 7. Certificates 72279, 72281 and 72283 are modified. The Department will issue a superseding certificate on a determination that it is necessary for recordkeeping.

- 12. The proposed change in place of use would not result in enlargement of the rights.
- 13. The proposed change in place of use would not result in injury to other water rights
- 14. The application was not filed prior to the end of the calendar year in which the changes occur as required under ORS 540.580(2). However, the District had notified the Department of the proposed changes in accordance with ORS 540.580(3). The Department's review of the noticed changes found they caused no injury. Having found no injury, the Department was not required to order the District to cease delivery of water or mitigate injury as authorized by ORS 540.580(5). Although the filing date of the application represents a failure to comply with statutory criteria, the late filing does not warrant issuance of notice of violation nor does it produce measurable or irreparable harm to the use of the state's water resources and the public interest.

Conclusions of Law

The proposed changes in place of use in Transfer Application T-10059 satisfy the requirements of ORS 540.574(3) and 540.580, with the exception that the application was not received prior to the end of the calendar year in which a change in place of use occurs as required under ORS 540.580(2). See Finding of Fact #13.

Now, therefore, it is ORDERED:

- 1. The proposed changes to the water rights evidenced by Certificates 72279, 72281 and 72283 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 72279, 72281 and 72283 and any related decree.
- The former place of use shall no longer be irrigated as part of this water right. 3.
- The proposed change shall be completed on or before October 1, 2009. 4.
- 5. The portion of Water Use Permit S-47284 described in Finding of Fact #9 shall not be perfected under the terms and conditions of the water use permit.
- 6. A Claim of Beneficial Use shall be submitted by the applicant to the Department by October 1, 2010.
- 7. Certificates 72279, 72281 and 72283 are modified. The Department will issue a superseding certificate on a determination that it is necessary to produce a certificate describing the right.

I have reviewed the above referenced files, field forms and maps for the above referenced permits.

My major concern in regards to complete proposed certificates is a letter in File G-8539, which states Permit G-7957 would be supplemental to File 64499, Permit 47284. If this is the case, the map prepared is in error as to the overlap in Section 4 of Permit G-7957. The permittee should be contacted to determine the extent of use of the underlying right and map adjusted accordingly. Please note the map submitted by NUID described the number of acres within the two quarter-quarter section are 20 to 30 percent different in area and should be rechecked to determine which are correct. Ben advises me the use under Permit No. 47284 may change due to a ORS 540.580 transfer pending by the district.

Since this is being revisited, I would like clarification of the dates of completion of the irrigated lands to determine if all the land was irrigated within the terms of the permits. The reason for my concerns is a survey done by Ben in 1990 did not include land that Ralph included in his survey in 1995, both surveys completed after the completion dates of the permits. There is no definitive statement in the report why more lands were found irrigated in our second visit. Any land not irrigated within the terms of the permits may be mapped, but should not be shown or included in any proposed certificate. I would like clarification as to the dates of completion of construction and use of water under all permits.

Nothing in the reports indicates that the permit holder was ever contacted to verify any information obtained. This causes a great concern about the accuracy of any claim because the permittee should be asked to point out the boundaries of the areas irrigated, describe how the land is irrigated and verify if the permit conditions were met. All of this information should be included in the reports.

In the case of Permit No. 47284, the names and address of each land owner should be obtained and interviews with each owner should occur to verify the use. The report does not describe the source, inspection of any diversions, calculations, etc.

I am returning the field forms for each permit for correction and completion. I have not specifically described all the deficiencies, but would suggest a review of the standards for completion of surveys be made and if any questions remain to contact me.

confirms the right to use the waters of CROOKED RIVER, a tributary of DESCHUTES RIVER, for IRRIGATION OF 56.2 ACRES.

This right was perfected under Permit 47284. The date of priority is OCTOBER 21, 1982. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.40 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 13, T 14 S, R 13 E, W.M.; 590 FEET NORTH AND 2790 FEET EAST FROM THE W 1/4 CORNER OF SECTION 13.
