- 3. On March 10, 2023, the Department received the permit recording fee.
- 4. The findings of fact in the Proposed Final Order are incorporated herein.

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 536.075 and ORS 183.484. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
