Downstream to the mouth, river mile 0, within the SE quarter of Section 11, Township 33S, Range 2E W.M., in Jackson County.

5. Technical data relied on in this application are published in the Rogue River Basin Investigation report. This report was submitted to the Oregon State Water Resources Board in These data are based on instream flow studies conducted by Oregon State Game Commission personnel in 1967.

The method used to determine the requested flows was "the Oregon Method" as described in Determining Minimum Flow Requirements for Fish, ODFW, 1984, a document previously submitted to Water Resources Department, Salem, Oregon.
