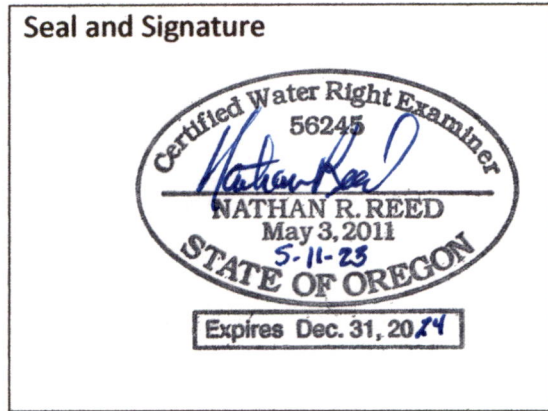

Contracted Galesville stored water is re-diverted at POD #2 along the Umpqua River with a 1.5 Hp submersible pump, discharged and conveyed to POU with buried network 1.5-inch ABS, to irrigation impact sprinkler heads in ten different zones of five heads. Metering is by a dedicated power meter.
