NOTICE OF CERTIFICATE ISSUANCE

The attached certificate confirms the water right established under the terms of a permit issued by this department. The water right is now appurtenant to the specific place where the use was established as described by the certificate. The water right is limited to a specific amount of water, but not more than can be beneficially used for the purposes stated within the certificate.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within **60 days of the mailing date stated above** as specified by ORS 183.484(2).

This statement of judicial review rights is required under ORS 536.075; it does not alter or add to existing review rights or create review rights that are not otherwise provided by law.

Under ORS 537.260 and 537.270, a water right certificate may be contested before the Water Resources Department within three (3) months of the date it is issued. If a certificate is contested, the qualifying contestant shall be offered an administrative hearing.

Oregon law does not allow the Director to reissue a certificate because of a change in the ownership of the appurtenant place of use. The water must be controlled and not wasted. To change the location of the point of diversion, the character of use, or the location of use requires the advance approval of the Water Resources Director.

If any portion of this water right is not used for five or more consecutive years, that portion of the right may be subject to forfeiture according to ORS 540.610. Land enrolled in a Federal Reserve Program is not subject to forfeiture during the period of enrollment. Other exceptions to forfeiture are explained in ORS 540.610.


Conclusions of Law

The additional point of appropriation and character of use proposed in application T-10026, appear to be consistent with the requirements of ORS 537.705, 540.505 to 540.580, and OAR 690-380-5000.

Now, therefore, it is ORDERED:

1. The changes proposed in T-10026 are approved.
2. Water right certificates 42441, 28028, 79199 and 72439 are cancelled.
3. The right to use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 42441 and any related decree.
4. Water shall be acquired from the same aquifer (water source) as the original point of appropriation.
5. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2007**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
6. The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.
7. When required by the Department, the water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
8. A new certificate will be issued for the portion of the right evidenced by Certificate 79199 not cancelled by this order.
9. When satisfactory proof of the completed changes is received, a new certificate confirming the right transferred will be issued.

CLAIM OF BENEFICIAL USE AND SITE REPORT

INFORMATION:

This report is in conjunction with the final proof survey for the irrigation of lands from a new well as applied for by B.L. DAVIS RANCH INC., P.O. Box 159, Adams, Oregon 97810, Telephone number 503-566-3563.

Prior to my inspection of the site, I discussed the system with Roger Davis, manager of this ranch and son of B.L. Davis who is the owner of the ranch. Mr. Davis informed me of the general operation of the system, and showed me the location of the new well (point of diversion) which delivers the water to the fields cited in application Number G 12056. Mr. Davis also showed me well number one which delivers 5.00 cfs to the fields under permit number G 3470. Both systems are tied together in order to deliver the water to the fields.

I noted that use had been made of this water on the fields as applied for in the irrigation of Potatoes, Grain, and Pasture.

The point of diversion (New Well) is an 8" Berkeley vertical shaft turbine pump. There is a 100 HP Electric Hollowshaft motor that turns the pump at 1800 RPM's. I do not have any results of a pump test. The water is distributed by means of 2608 feet of buried 8" PVC to an 800 GPM Center Pivot with a 100 Series Nelson Big Gun with a .7" nozzle on the end. I refer to this pivot as pivot number 1 and is located in the SE $\frac{1}{4}$ of Section 17. Water is also distributed by 8476 feet of buried 8" Transite pipe and 2482 of 8" Steel mainline laid on top of the ground to a second 800 GPM center pivot with a 100 Series Nelson Big Gun with a .7" Nozzle, as well as a big 1600 GPM Center Pivot with a Series 100 Nelson Big Gun with a .7" Nozzle. I refer to the second pivot as pivot number 2, which is located in the SW $\frac{1}{4}$ of Section 16. Pivot number 1 and 2 overlap with the big guns. The large pivot is situated in section 21 and has 17 towers. The water is applied, in addition to the center pivots, by 4 - 5 inch wheel lines, all four were 1/4 mile long. Two had 24 heads with 3/16" nozzles and two had 12 heads with 11/64 nozzles. Mr. Davis said that they operated the pivots and wheel lines at 50 psi at the heads. I also observed 37 wheels and heads in a storage area near the new well. Mr. Davis indicated that

these lines were used on occasion on this ranch. These (37) pipes and wheels were separated and in a pile. There were 13 heads with 11/64 nozzles and 24 heads with 3/16 nozzles. The pipes were also 5 inch. The 8 inch steel pipe that is laid on the ground was not visible and is stored elsewhere according to Roger Davis. The wheel lines are used along the North tier of 40's in section 21 and 22. The NE NE of Section 21 and the NW NW of section 22 are watered by wheel lines and the water is transported in 8" steel lines above ground.

There was no water being applied on the day of my inspection, however it was apparent that the system had been used in the manner applied for. Mr. Davis told me that he had irrigated the fields this past summer, and I could see the circle tracks in the fields indicating usage of the system. It is obvious to me that the water is being used in a beneficial manner.

I find a slight difference in the tie from the SW corner of Section 16. I now find the Point of Diversion (Well) to be North 106.7 feet and East 11.6 feet from the SW corner of Section 16, which I find to be a fence corner. My difference is due to scaling the distance on a quadrangle map for the application. I retied the Section corner using a Solar Observation for bearing and tied all of the center pivots and the ends of the pivots with a Wild TC 1600 with data collector and added the radius of the big guns to determine the extent of the watering.

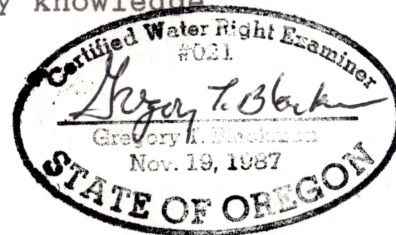
At this time it is my observation that the conditions of the permit , except for the pump test, have been met. The system is in place and is capable of being used as applied for.

The final proof survey and inspection of the usage, found to be completed except for the required pump test under the terms and conditions of Permit G-11116 was completed by me on February 23, 1993, and the facts contained in this report and accompanying final proof map are correct to the best of my knowledge.

This right was perfected under Permit G-11116. The date of priority is MARCH 29, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ---- CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

Consideration for Approval of Application G-12056 to Use Water from One Well in the Grande Ronde River Basin for Supplemental Irrigation, B. L. Davis Ranch, Incorporated, Union County.

Background:

On March 29, 1990, B. L. Davis Ranch, Incorporated, submitted Application G-12056. Application G-12056 (Attachment 1) proposes to use up to 6.78 cfs of water from a well for supplemental irrigation on 942.6 acres. The project is located in the Grande Ronde River Basin (Attachments 2 and 3).

The question before the Commission is whether the issuance of a permit for use of up to 6.78 cfs of water from a well in the Grande Ronde River Basin would have a significant adverse effect on the public interest. OAR 690-11-080 (2)(a)(A) specifies that appropriations for greater than 5.0 cubic feet per second be referred to the Commission to make a public interest determination under ORS 537.170.

Evaluation:

The applicant proposes to use 6.78 cfs for supplemental irrigation. The well is above the Grande Ronde Scenic Waterway. The Groundwater Section reviewed the project for the scenic waterway and Diack. The well develops water from an unconfined aquifer and is located more than a 1/4 mile from the nearest stream. They concluded that the use of water from the well will have no significant interference with the river and its use will have no impact on the scenic waterway.

Notice of this application was provided to the public. Staff did not receive any comments.

According to the information from the Groundwater Section, the use of water poses no problems for the stream system or other natural resources in the area. Staff does not believe that this proposal would have a significant adverse effect on the public interest (Attachment 4).

Alternatives:

1. Find that the proposed use of water may have a significant adverse effect on the public interest, and schedule a hearing to assist the Commission in making its determination.
2. Find that the proposed use of water would not have a significant adverse effect on the public interest, and authorize the Director to issue the permits with the appropriate conditions.

Summation:

The proposed use of water is for supplemental irrigation. Water is available, and its use should not have a significant adverse effect on the water resources in the basin.

Director's Recommendation:

The staff recommends Alternative 2, that the Commission find that the proposed use of water would not have a significant adverse effect on the public interest and authorize the Director to issue the permit.

The application referenced above and available data has been reviewed under the guidelines of the Director's policy memo of October 19, 1989.

We find that the proposed groundwater use falls within the following category:

 CATEGORY 1A - The proposed well will be located less than 1/4 mile from the nearest stream, and significant surface water interference will exist.

 CATEGORY 1B - The proposed well will be located less than 1/4 mile from the nearest stream, but significant surface water interference will not exist.

✓ CATEGORY 2A - The proposed well will be located more than 1/4 mile from the nearest stream, and significant surface water interference will not exist.

 CATEGORY 2B - The proposed well will be located more than 1/4 mile from the nearest stream, but significant surface water interference will exist at the nearest point on the stream.

REMARKS: Well develops unconfined groundwater; it is located approx.
4600 from McListon Slough, a natural tributary to the Grande

We received your application on March 29, 1990, describing the proposed use of 6.78 cubic feet per second of water from one well within Grande Ronde River Basin for supplemental irrigation of 942.6 acres. Supporting data and fees in the amount of \$2165.20 were also received. Our Receipt 62067 is enclosed.

You are receiving this notice because you have a water right application pending with the Water Resources Department. Your proposed water development project is located within or upstream from a state scenic waterway. A recent Oregon Supreme Court decision (*Diack*) requires the Water Resources Commission to make certain findings about applications in these locations.

The Commission has directed the Department to postpone further processing of applications in these locations until the streamflows necessary for recreation and fish and wildlife uses within the scenic waterway have been determined. We are working with State Parks Division, Departments of Fish & Wildlife, and Environmental Quality to make these determinations as quickly as possible.

We expect the scenic waterway flows will be determined June, 1991, for your area.

Even though your application is within or above a scenic waterway, we will process your application in the normal manner if it fits any one of the criteria listed below:

- A. You propose to use groundwater that is not hydraulically connected to the stream located within or tributary to the state scenic waterway. Usually this means that your well would need to be at least one mile away from the nearest stream.
- B. Your proposed use of water is non-consumptive. It would pass through your project and return in equal amounts at a location upstream from the scenic waterway.
- C. You propose to contract for stored water as either your primary or supplemental source of supply and the owner of the stored water is willing to give you a contract.

- D. You propose to transfer an existing water right certificate by moving either the point of diversion or the place of use. You believe that such move will not change the amount of water in the stream from your current practices.

If your project does not fit into one of the above categories (A-D), you may want to modify it so that it does. Submit those modifications to us. If you can not modify your application to fit one of the above categories, you may want to consider one of the options below:

1. Leave your current application pending with us to hold your tentative priority date. After the flows are quantified, we will resume processing your application. If it turns out that not enough water is available to meet the recreational demands for the scenic waterway, we may have to deny your request. The examination fees will not be refunded, but any recording fees you submitted will be refunded.
2. Withdraw your application. The examination fee is non-refundable, but any recording fees which were submitted will be refunded. If after flows needed for the scenic waterway are quantified you believe that there is enough water left for your proposed use, file a new application with the appropriate fees to establish a new priority date. Your new application will then be processed using more definite information regarding the availability of water for your proposed use.
3. Conduct sufficient flow studies of your own using methods approved by Parks Division and Fish & Wildlife. Then, submit information demonstrating that your proposed use of water will not impair the flows needed for the scenic waterway.

We advise you to avoid committing any resources toward your project on the assumption that your permit will be issued. Use of water cannot legally be made without the permit and the outcome of the scenic waterway study is not predictable at this time. Some streams are likely to have no water available except during high flow periods. It is possible that there will not be enough water left for your proposal after the studies are done.

If you want to wait for the results of the flow studies, you do not need to contact us. We will assume that you want to leave your application pending (alternative #1, above).

If your choice is either alternative #2 or #3, please return this letter with your comments.



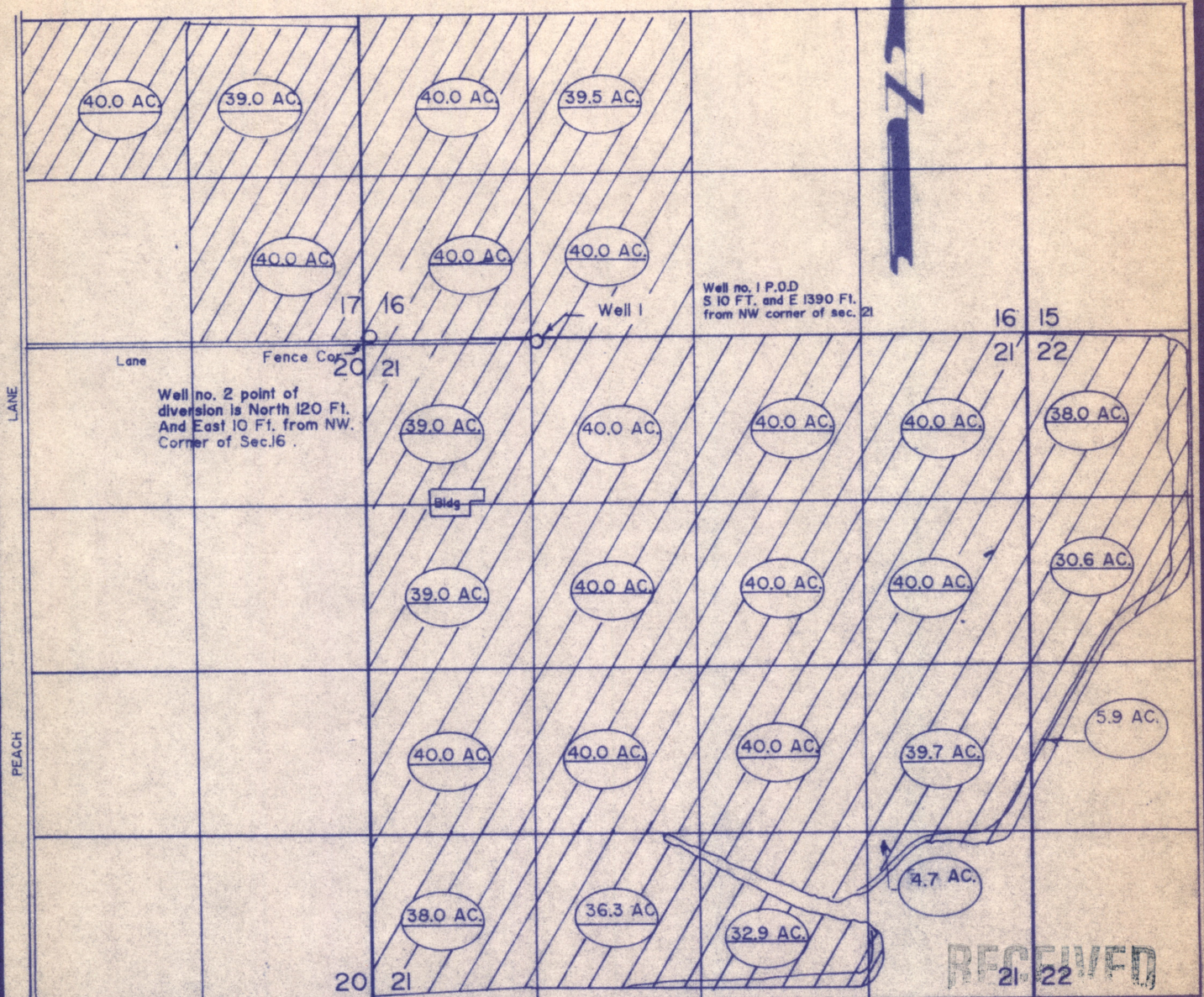

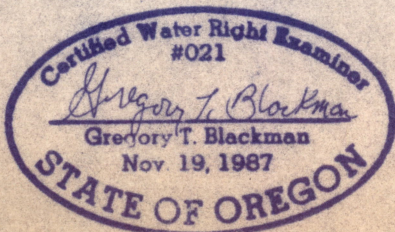
