Enclosed are documents in Application for a Permit to Construct two Reservoirs under the provisions of House Bill 2153. The application form used herein was developed, and mutually agreed to, as a result of discussions with Jake Szeramak, in your office. To meet Oregon statutory requirements, both this cover letter and the enclosed form jointly serve as the application. Statutory mapping requirements will be met by three maps, submitted under separate cover, which show the general location of all water storage projects for which a water right application is being made.

This application should be processed according to the provisions of HB 2153; all listed reservoirs should be processed as a single application. These reservoirs are located on Federally managed lands, and are listed in the appropriate County Assessor's Office as on property owned by the United States of America.

The reservoirs were constructed prior to 1987.
