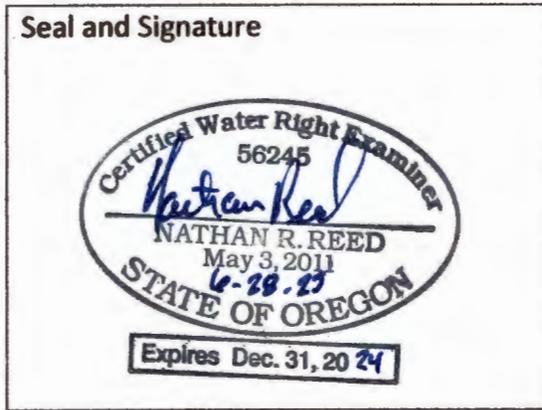

A 1.0 Hp fish screen submersible pump pumps water from North Umpqua River through 1-inch diameter ABS above ground along the river bank to a totalizing flow meter. From there, the pipe is buried to deliver water to the house and landscape in three zones of elevated spray heads and drip heads.
