Summary: Order approving Application S-89352, as amended, and issuing Permit S-55499.

Authority

- 1. On March 23, 2023, Art Kuenzi and Kuenzi Family Vineyard submitted an application to the Department for a water use permit.
- 2. On August 8, 2023, the Department issued a Proposed Final Order recommending approval of the application. The protest period closed September 22, 2023 and no protest was filed.
- On August 28, 2023, the applicant submitted payment of the \$610.00 permit recording fee to the Department.
- 4. The findings of fact in the Proposed Final Order are incorporated herein.

CONCLUSIONS OF LAW

- 1. The conclusions of law in the Proposed Final Order are incorporated herein.
- 2. The proposed use, as conditioned, would not impair or be detrimental to the public interest.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 536.075 and ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to OAR 137-004-0080, you may petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
