Water Rights Description

Oregon Water Resources Department Water Right Certificate No. 88637, which authorizes year-round use of 0.87 cubic foot per second from Well 25 in the Muddy Creek Basin for Quasi-Municipal Use with a priority date of May 20, 1998;

Oregon Water Resources Department Water Right Certificate No. 89220, which authorizes use of stored water from Currant Reservoir for storage in Muddy Station Reservoir and for appropriation under Permit S-53506 for Quasi-Municipal Use with a priority date of June 5, 1997; and

Oregon Water Resources Department Water Right Certificate No. 89221, which authorizes year-round use of an annual volume of 2,010 acre-feet of stored water from Currant Reservoir, constructed under Permit R-8452, and 35 acre-feet of stored water from Muddy Reservoir constructed under Permit R-12578, tributaries of Muddy Creek, for Quasi-Municipal Use with a priority date of June 16, 1997.
