This notice is submitted pursuant to ORS 537.141, which provides, that a water right is not needed for certain ponds/reservoirs which were in existence before January 1, 1993, are located off-channel and store less than 9.2 acre-feet of water or have a dam less than 10 feet in height.

I/WE SUBMIT NOTICE OF THE FOLLOWING RESERVOIR(S):

1. The reservoir is located in Section 8, Township 16S, Range 1W, in LANE County. (Enclose a US Geological Survey topographical map or a tax lot map showing the location of the reservoir(s). - 7.4 Construction receipts or other forms of documentation.

Declaration by Owner/Authorized Agent:

Each of the reservoirs described herein was in existence before January 1, 1993, is located off-channel and stores less than 9.2 acre-feet of water or has a dam less than 10 feet in height.

I/We believe the reservoir(s) qualifies under ORS 537.141 and OAR 690-11-041 for exemption from Oregon's water right filing requirements.

Notice to Owners/Authorized Agent:

Reservoirs that qualify for exemption under ORS 537.141 and OAR 690-11-041 shall be subject to the following conditions:

1. The right to store or use water in the reservoir shall not have priority over any water right; and
2. The right to store and use water in the reservoir(s) shall be subordinate to all future permitted or certificated water rights.

The Paschelke family has owned the homestead, where our pond is located, since 1904. The pond is fed by a year-around spring and its drainage created about three acres of marshland as it worked its way down to a drainage ditch along Paschelke Road. While there's a fairly steady flow during wet times of the year, dry summers find the water movement very slow.

When my husband's mother wanted us to buy the farm from her in 1947 so she could move to Eugene, we did. Then we did a moderate amount of digging to create a pond deep enough and cool enough to support rainbow trout. We purchased a thousand seven inches from a trout farm west of Portland and stocked the pond.

We put a mesh screen with a heavy wood frame across the outlet, according to directions we got from the Fish and Game Commission and received a letter from them exempting us from the Oregon Fishing Rules. We had a very simple earth dam with the screened spillway. But, because of continued beaver damming, which raised the level of the pond over a foot higher, our dam now seems to be completely covered by the beaver dam.

Because the pond covers an area that was formerly a swamp, all kinds of natural life abound there. Besides the beaver, there are frogs, pond turtles, Mallards and usually a few Canadian Geese, visiting a neighbor's tame geese. For a long while, we've had two pairs of nesting blue herons.

The whole area is completely naturalized now and the people around here consider it a community asset. It is close enough to Paschelke Road, though screened by trees and brush, that many passersby pause awhile to watch the life in the lake and admire the view of the hills beyond.

If any place deserves to be an exempt use, I'm sure this one does. I await your decision.



RESERVOIR EXEMPTION REQUEST
FILE P - 74475

Today I inspected this reservoir with regards to exemption under HB - 2153.

The flow originates on or near the reservoir site. There is a dam 5 - 6 feet high causing the impoundment.

The dam has a overflow that goes into a ditch along the County road, then under the road through a 18 inch culvert, and into Mill Creek. In her letter to WRD, Ms. Paschelke tells of " steady flow during wet times of year" , from her pond to this ditch.

No flow was evident over the dam during the inspection, but has evidence of winter flows into Mill Creek.

It does not appear that this reservoir qualifies for exemption under HB - 2153.
