

One pump has an 8 inch diameter discharge and the second pump has a 10 inch discharge, which are manifolded together to a 10 inch mainline sixed down to a 8 inch mainline sixed down to a 6 inch mainline to a 5 inch wheel line which is applied by rainbirds to the fields.
