





ABSTRACT OF CERTIFICATE OF WATER RIGHT NO.15328

Nellie D. Haws of Rt. 2, Box 490, Grants Pass
State of Oregon , has made proof to the satisfaction of the State Engineer of Oregon, of a right to the use of the waters of China Gulch

a tributary of Pickett Creek to Rogue River , for the purpose of domestic & irrigation, being 0.01 c.f.s. for domestic & 0.13 c.f.s. for irrigation under Permit No.16031 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 19, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second

or its equivalent in case of rotation . The point of diversion is located in the NE_4^1 SE_4^1 , Sec. 27, Twp. 35 S., R.7W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80th of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10 acres in the SE NE of Section 27, Township 35 South, Range 7 West, W. M.

The right to the use of water for the purposes aforesaid is restricted to the lands or place of use herein described.
