

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Marion County, State of Oregon, described as follows, to-wit:

A Parcel of land lying in lots 8, 9, & 10, Whitney Acres, Marion County, Oregon; the said parcel being described as follows:
Beginning at a point which is opposite and 120 feet Southeastery of Engineer's station 109 & 00.44 on the center line of the Pacific Highway (Formerly the Portland-Salem Expressway), said point being 84.31 Feet North and 2919.06 Feet East of the Northwest corner of the Patrick M.
