Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

On April 30, 1999, Permit S-53380was issued by the Department. The permit called for and complete application of water to beneficial use by October 1, 2002. The most recent extension authorized complete application of water to beneficial use by October 1, 2005. On December 15, 2023, Scott and Cheryl Ogilvie submitted an Application for Extension of Time for Permit S-53380. In accordance with OAR 690-315-0050(2), on March 19, 2024, the Department issued a Proposed Final Order proposing to deny the time to apply water to full beneficial use from October 1, 2005 to October 1, 2028. The protest period closed May 3, 2024, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The Department adopts and incorporates by reference the findings in the Proposed Final Order dated March 19, 2024.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, the permit may not be extended.

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.230, 539.010(5) and OAR 690-315-0040(2).

ORDER

The extension of time for Application S-81526, Permit S-53380, therefore, is Denied.
