

"SAM'S GARDENS" Legal description

Commencing at a point in the center of the County Road No. 681, 33.90 chains South $88^{\circ} 30'$ East from a point in the West line of the Felix Scott Sr. and wife Donation Land Claim, Notification No. 3255, Claim No. 82, Township 17 South, Range 2 West of the Willamette Meridian, and 22.50 chains South of the northwest corner of said claim; running thence along the center of said county road South $88^{\circ} 30'$ East 6.755 chains; thence at right angles to said road North $1^{\circ} 30'$ East to the left or south bank of the McKenzie River; thence with the meanderings of said bank down stream to a point North $1^{\circ} 30'$ East of the beginning point and thence leaving said river and running South $1^{\circ} 30'$ West 34.44 chains to the place of beginning, containing 27 acres, in Lane County, Oregon.

Beginning at a point 22.64 chains South of a point 26.11 chains East of the Northwest corner of the Felix Scott and wife Donation Land Claim, Notification No. 3255, in Township 17 South, Range 2 West of the Willamette Meridian; running thence North 30.49 chains to the left bank of the McKenzie River; thence along said bank North $73\frac{1}{4}^{\circ}$ East 3.30 chains; thence North $66\frac{1}{2}^{\circ}$ East 3.76 chains; thence North $52\frac{1}{2}^{\circ}$ East 1.35 chains; thence South 33.68 chains to a point due East of the beginning point, and thence West 7.60 chains to the place of beginning and containing 24.13 acres of land, more or less, in Lane County, Oregon.
