





Dear Mr. Williams:

We are enclosing herewith for completion, final proof in connection with the incomplete water right represented by your Permit No. 19134 granting a right to the use of 0.005 cfs of the waters of Clackamas River for the irrigation of 0.4 acre of land.

The data contained in the proof, which is based on an inspection and survey of your project made by a representative of this department, defines the extent to which your water right has been completed within the terms of your Permit. The proof should be dated and signed by you on the second sheet under the Affidavit of Appropriator and returned to this office.

Upon receipt of the proof, properly executed and accompanied by the statutory fee of \$1.00, a Certificate of Water Right will be issued confirming the rights thereunder and, after being recorded in the records of Clackamas County, will be forwarded to you.


