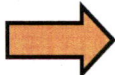

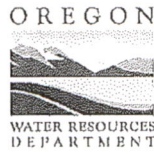

LEGAL DESCRIPTION: Real property in the County of Clackamas, State of Oregon, described as follows:

Part of the North one-half of the Southeast one-quarter and part of the Northeast one-quarter of the Southwest one-quarter of Section 18, Township 5 South, Range 1 East, of the Willamette Meridian, in the County of Clackamas and State of Oregon, to-wit:

Beginning at the center of said Section 18; thence South 73 rods; thence West 8 rods; thence Northwesterly 73 rods, more or less, to a point on the quarter section line running East and West through said section which is 14 rods West of the center of said Section; thence East 14 rods to the point of beginning.
