

Enclosed you will find a copy of the map on file with OWRD which depicts the place of use for the referenced water right. The certificate authorizes group domestic use for 56 families, and, as it happens, there are 56 X's on the map denoting use. The circled X's indicate "served with water but not yet built."

Since ORS 540.510(3) was modified by the 1995 Legislature, the Siltcoos Heights Water System may use water on lands to which the water right is not appurtenant since the use is domestic use, a component of municipal use, and the system is a water supplier as defined in ORS 448.115. Thus, 56 homes may receive domestic service from the system regardless of their location and 10 campsites may receive domestic water regardless of their location under the existing water right. However, no more than 56 homes may be served under the existing water right.

As I indicated in our phone conversation, a transfer application changing the use of this water right to quasi-municipal use is a viable option in order to serve more than 56 homes. Another option would be filing a new application for additional water. A new permit, however, may be limited to human consumption use only.

Our records show that certificate of water right recorded at page 48728, Volume 42, State Record of Water Right Certificates, has been issued to Bernard La Forge. The certificate confirmed the right to the use of 0.07 cubic foot per second of water from Siltcoos Lake for group domestic purposes for 56 families and 10 campsites under a date of priority of October 18, 1971.

A completed and perfected water right as evidence by a certificate remains valid and in force indefinitely; however, all or a portion of the right can be lost through intentional abandonment or through failure to exercise the right for a period of five successive years.






