

The use of water for pond maintenance shall be limited to 0.146 cfs before June 15 and 0.073 cfs after June 15 and shall be further limited to a diversion of not to exceed 24.0 acre-feet during the irrigation season being March 1 to October 31 of each year.

Diversion of pond maintenance water began prior to 10/1/2004 in compliance with the authorized diversion period and diversion rate. The use for pond maintenance was proven for the extension application and noted as approved in the extension final order.

The water user shall install and maintain a fish screen or fish by-pass device. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife (ODFW) prior to beginning of construction and shall be installed under the supervision of the ODFW.

The fish screen was installed and inspected by ODFW in February 2004. The fish screen and bypass were approved by the ODFW, as documented in a letter from ODFW dated May 20, 2021 (attached). This letter was provided and accepted as part of the extension application and noted in the extension final order.

The diversion was identified as an existing POD on the existing transfer maps and prior certificate, this location was confirmed and included on the COBU map attached.

The place of use was walked with a Garmin GPS to establish a perimeter of way points and correlated with aerial photography available from Google Earth Pro to determine the extent of the POU development.

The POU of the reservoir and pond maintenance POU was established by review of aerial photography available from Google Earth Pro.

The POD for the transfer is located at the base of the dam and a Garmin GPS was used to pin the location of the reservoir outlet pipe where the irrigation pump station is located.



Dear Mr. Long,

Your fish screen was inspected on 2/3/2004. In reference to water right permit R-13455 this letter confirms that a National Marine Fisheries Service criteria fish screen as approved by ODFW is located on the property near GPS coordinates: 44.618301, -120.340527.

In regards to the inspection of the fish screen located on Bear Creek, the following has been determined:

- 1. The screen located at coordinates 44.618301, -120.340527 is an ODFW shop-built 5'x18" solar powered rotary drum screen.
- 2. This screen is approved for water use up to 888.82 GPM or 1.98 CFS at 75% submergence.
- 3. All screen configurations meet National Marine Fisheries Service criteria at the time of inspection, any changes or modifications to the configurations will not be covered by this certification letter.
- 4. This screen is equipped with a 10" diameter by-pass pipe returning to the creek.
- 5. ODFW fish screening and passage program periodically inspects this screen as part of their continued maintenance program, contingent on continued funding availability.

#### Authority

Oregon Administrative Rules (OAR) 690-380-5140(2) authorizes the Department to grant an extension of time to complete a transfer.

OAR 690-380-6020 establishes an application process and criteria for the review of extensions of time to complete a transfer as authorized by a final order issued under OAR Division 380.

OAR 690-380-6020 (3) establishes that extensions are granted for one year, from October 1 to October 1 of each year. Extensions may be granted for longer time if the applicant can justify the need for a longer period of time by submission of pertinent evidence.

#### **Findings of Fact**

- On April 4, 2003, the Department issued an order (Final Order) approving Transfer Application T-8691 to change a place of use and a character of use under water right Certificate 78512. The order was recorded in Special Order Volume 57 Pages 329-332. The order set a transfer completion date of October 1, 2004.
- 2. On December 1, 2021, the Department sent by certificated mail, notification to the applicants and landowner that Transfer Application T-8691 had not been completed with a Claim of Beneficial Use. Changes to the water rights that approved in the final order were to be completed by October 1, 2004.

# NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 3. On December 28, 2021, the Department received an application for extension of time for Transfer Application T-8691.
- 4. On April 27, 2022, the Department signed a final order approving the extension for T-8691, which was mailed on April 28, 2022, and recorded at Special Order Volume 122, Pages 940-942.
- 5. This order is issued to correct the erroneous references to Oregon Administrative Rules 690-385 and supersedes the Final Order recorded at Special Order Volume 122, Pages 940-942. The prior final order cited Oregon Administrative Rules 690-385 the which are not applicable to Transfer T-8691. This superseding correcting order is being issued under the applicable Oregon Administrative Rules 690-380.
- 6. Certificate 78512, in part, authorized the irrigation of 9.9 acres from Bear Creek, a tributary of Bridge Creek. The Final Order approved a change in place of use for 3.9 of the authorized acres, and a change in place of use and character of use for 6.0 acres from irrigation for and equivalent amount of water to be used for pond maintenance in an reservoir located in the NWSE and SWSE Section 9, Township 11 South, Range 20 East, W.M..
- 7. Per the applicant's extension application and aerial photographs, since the approval of the transfer, the applicants have appropriated water to the reservoir located NWSE and SWSE, Section 9, Township 11 South, Range 20 East, W.M. for pond maintenance, and installed a fish screen.
  - a. Transfer T-8691 allows for diversion up to 0.146 cubic foot per second before June 15 and 0.073 cubic foot per second after June 15, further limited to a diversion of not to exceed 24.0 acre-feet during the irrigation season being March 1 to October 31 of each year for pond maintenance.
  - b. Transfer T-8691 does not provide for additional storage capacity beyond what is authorized under the reservoir right to store water under Permit R-13455 but is an authorization for a secondary right to maintain the storage right under Permit R-13455. <sup>1</sup>
  - c. The installed fish screen and bypass has been approved by the Oregon Department of Fish and Wildlife, as documented in a letter from ODFW dated May 20, 2021.
- 8. To fully complete the change, the applicant needs to irrigate and additional 2.4 acres with water obtained from Bear Creek at the proposed place of use.
- 9. The applicant has requested that the time for completion of beneficial use be extended to October 1, 2022. Consistent with OAR 690-380-6020(3), the Department will extend the transfer completion date to October 1, 2023.

<sup>&</sup>lt;sup>1</sup> Permit R-13455 provides that following condition: This permit does not provide for the appropriation of water for any out of reservoir uses, the maintenance of the water level or maintaining a suitable fresh water condition. If any water is used for out of reservoir uses, or any live flow is appropriated to maintain either the water level or a suitable fresh water condition, a secondary water right is required.

# Conclusions of Law

Pursuant to OAR 690-380-6020, the Director of the Water Resources Department concludes the applicant has shown reasonable diligence to complete the transfer within the time period established by the order approving Transfer Application T-8691.

# Now, therefore, it is ORDERED:

- 1. The order entered at Special Order Volume 122, Pages 940-942 is withdrawn and of no further force and effect and is superseded by this order.
- 2. The time for completion of the changes authorized by Transfer Application T-8691 shall be extended to **October 1, 2023.**
