

Dear Jonathan,

Regarding OWRD Transfer-12225, ODFW cost shared a Pump Rite L250 screen at point-of-diversion #3 (42.1487, -122.94522). This cost shared project meets current fish protection criteria, and fish bypass devices are not necessary. Current water user retains minor maintenance responsibility and ODFW retains major maintenance responsibility on the screen. This approval is contingent on the following: current conditions remain unchanged, screens are installed so effective screen area is submerged during operation, the screen is regularly inspected and maintained to ensure it remains in working order (including debris removal), and the screen is annually inspected when it is not in use. Thank you.
