

Regarding OWRD Permit S-51808, ODFW has determined the fish screen at the point-of-diversion located at 43.307816, -123.124233 meets current fish protection criteria. Fish bypass devices are not required due to no obstruction present. This approval is contingent on the following: current conditions remain unchanged, screens are installed so effective screen area is submerged during operation, the screen is regularly inspected and maintained to ensure it remains in working order (including debris removal), and the screen is annually inspected when it is not in use.
