In order for your application to be processed by the Oregon Water Resources Department (OWRD), this Land Use Information Form must be completed by a local government planning official in the jurisdiction(s) where your water right will be diverted, conveyed, used, and developed. 

Please find accompanying this letter three application packages for new water right permits on behalf of Bandon Biota, LLC and Bandon Dunes Golf Reort (Applicant). These applications propose various water uses related to the operation and management of a proposed golf course south of Twomile Creek (Sections 13, 24, and 25 in T29S, R15W south of Bandon, Oregon). Specifically, these applications include:

- Supplemental irrigation from storage (proposed reservoir),
- Primary and supplemental irrigation from groundwater (existing wellfield), and
- Reservoir maintenance from groundwater (existing wellfield).

A fourth application package, which is for wintertime diversion from Twomile Creek for storage in the proposed reservoir, will be submitted following these applications. The Applicant is currently waiting for the ODFW Review Form to be returned for the Alternate Reservoir Application process.
