Irrigation of the nursery stock will be done with drip and impact sprinkler irrigation system using best management practices to prevent waste.

The ODFW has determined a fish screen was not needed to develop the storage use. If ODFW determines a fish screen is needed to pump the water out of the reservoir, we will attach the screen to the pump in the reservoir

The reservoir is located off channel in a gravel lot and therefore will not damage riparian or streamside areas

Construction for the point of diversion on the reservoir will disturb less than one acre.
