


PRE-1900 VESTED WATER RIGHT





In Summary, there has been a dairy herd or a beef herd on this property continuously since November 30, 1908 to the present date.

Tenne Filius Naapi continued raising a dairy herd from August 7, 1920 until September 10, 1950, at which time he switched to raising Black Angus beef cattle up until the time this property was sold on September 23, 1961 to Clarence H. Naapi and Leo L. Naapi. A copy of said deed is attached hereto as Exhibit B. We purchased the property with 22 beef cattle. We have continuously raised Black Angus beef cattle since September 23, 1961 to the present date.

This 120 acres was previously purchased by Christ Grohs from Aggie Johnson on July 10, 1914. A copy of said deed is attached hereto as Exhibit C. Aggie Johnson, an Umpqua Indian, was deeded this property from the United States of America on October 10, 1910. A copy of said deed is attached hereto as Exhibit D.
