On December 15, 1993, I inspected the water system and site of beneficial use as per SWR-160., in the name of George B. and William B. Camp. The owners of the property are the same George B. and William B. Camp. The address of the owners is: 12117 Highway 126 Mapleton, Or. 97453

#### SOURCE

The source of water is an unnamed creek tributary to Knowles Creek, which is tributary to the Siuslaw River.

### DIVERSION

The point of diversion is located 240 ft. south and 50 ft. west of the center of section 1, Township 18 South, Range 10 West. The diversion consists of a wood headwall of 2"x12" plank used to raise the creek water in order to empty fill a 1 1/4" pipe that extends through the headwall. The creek is approximately 2 feet wide at high flow at the point of diversion. A wood flume approximately 11 inches wide is used to carry the normal flow of creek water over the headwall. The creek has a waterfall located near the house that prevents passage of fish above that point. The capacity of the diversion is approximately 20 gpm. The elevation head from the reservoir to the house is approximately 130 feet.

### RESERVOIR

A 1350 gallon plastic above ground reservoir is located at shown on the Final Proof Map. Overflow from the reservoir is piped back into the creek. The inlet, outlet, and overflow are 1 1/2" diameter.

## APPLICATION OF BENEFICIAL USE

Remains of old intake and settling basins were found at various places along the creek. Fenced yards, gardens, fields and old orchards were areas irrigated. Fields, gardens, and orchard area

have been irrigated with up to 3 impulse type sprinklers operating at approximately 4 gpm per each, with the sprinklers connected to standpipes.





# DEAR MICHAEL N. MCALLISTER,

The Water Resources Department (WRD) received a little over 500 surface water registration statements in December, 1992. All of the files have been set up and reciepts for the fees have been sent. The next step is to insure the maps received in support of the claims are acceptable based on Oregon Revised Statutes (ORS) and Oregon Administrative Rules (OAR).

I am returning the map you prepared for George B. and William B. Camp. You will find the item which requires completion or correction shown below. I have the description followed by the ORS or OAR site and paraphrased statute or rule.

Leonveyance	ORS 539.120 "the location of and each ditch, canal, pipeline or other means of conveying the water"
1/place of use (1/4 1/4)	ORS 539.240 (2) (d) (B) "The location of place of use by quarter- quarter section" You need to identify the $\frac{1}{4}\frac{1}{4}$ or government lot on the map.
diversion point size	OAR 690-28-025-(4)-(c) "The dimensions and capacity of any existing diversion systems."
beneficial use title	This is a map to support a claim to a pre-1909 vested water right.

I am enclosing a copy of the checklist and claim to beneficial use report information used by the adjudication section. You may find it useful in preparing the required map and information Many Certified Water Right Examiners have seen these and are using them.

The application for permit process is not involved.



You must return the map before the claim can be processed. If you cannot have the map to the WRD within 60 days, please inform me as to when it can be expected. Please mark all correspondence with the file number.


