

Good morning Matt,

The Department has received the Claims of Beneficial Use (Claim) and fees for Permit R-14584 and S-54563. The Department is returning the Claim report and fee for Permit R-14584 to Glenn and Susanne Howard, as a Claim for Alternate Reservoirs was submitted, and the Claim report was not performed by a CWRE. ORS 537.409 does not authorize the permit holder to prepare their own Claim if a secondary permit has been issued to use the water stored under the reservoir. The above referenced permit is included as the source of water to be used under Permit S-54563.
