Enclosed please find an application for a permit to appropriate surface water. Also enclosed is a map prepared by certified water rights examiner Jack Burrell of K&D Engineering, Inc., and a check for the permit application fee of \$200.

Additionally, I am forwarding a corrected map for surface water registration statement #SWR-182. The initial water registration statement application submitted to your office on behalf of Kory and George Koos mistakenly requested only 200 gallons per minute for the amount of water claimed (#5 on the surface water registration statement 1909 vested water right claim). I miscalculated the amount of water required from that source, and after talking with your department and Mr. Burrell, I would request that the corrected amount of water claimed be changed to 409 gallons per minute. This will then match the amount on the permit application.

Also enclosed is a corrected map showing the number of acres requiring irrigation on SWR-182. The previous map submitted showed only 65.6 acres. This is an incorrect amount. The new map prepared by Mr. Burrell has corrected this inconsistency. The correct acreage, shown by the updated map, illustrates that 73 acres will be irrigated. 


