**Summary:** Order approving Application G-19276 and issuing Permit G-18952.

### ***Authority***

## **FINDINGS OF FACT**

1. On April 11, 2022, Vitaly Anfilofieff submitted an application to the Department for a water use permit.
2. On January 28, 2025, the Department issued a Proposed Final Order recommending approval of the application. The protest period closed March 14, 2025, and no protest was filed.
3. The findings of fact in the Proposed Final Order are incorporated herein.

## CONCLUSIONS OF LAW

1. The conclusions of law in the Proposed Final Order are incorporated herein.
2. The proposed use, as conditioned, will ensure the preservation of the public welfare, safety and health.

NOTE: When issuing permits, ORS 537.628(1) authorizes the Department to include limitations and conditions which have been determined necessary to protect the public welfare, safety and health.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 536.075 and ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to OAR 137-004-0080, you may petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. Only the applicant or protestant may appeal this order. (ORS 537.170(7)(b); ORS 537.625(2)(b)).

**ORDER**

Application G-19276 is approved, and Permit G-18952 is issued.
