

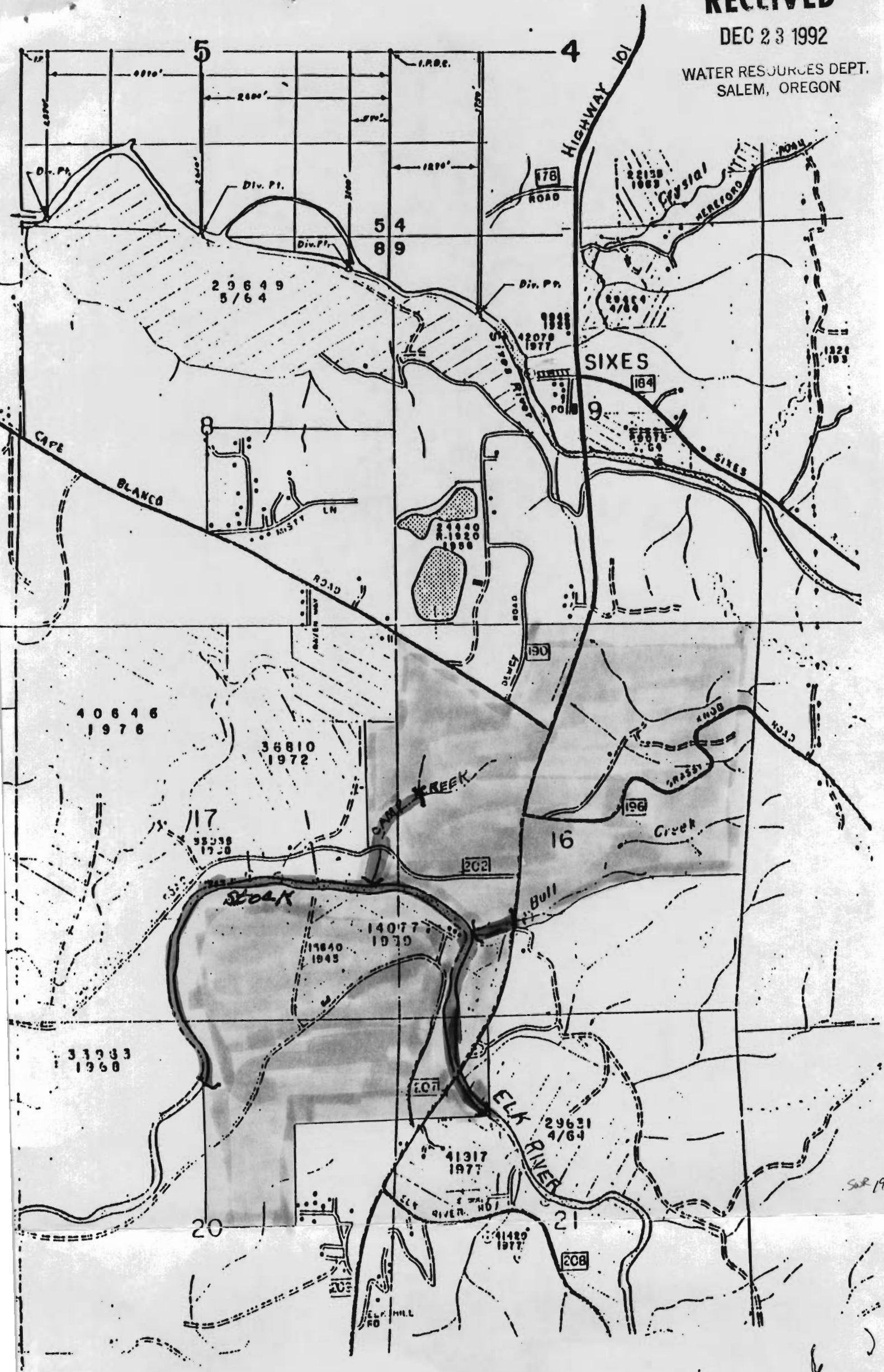


RE: Surface Water Registrations 189 & 190

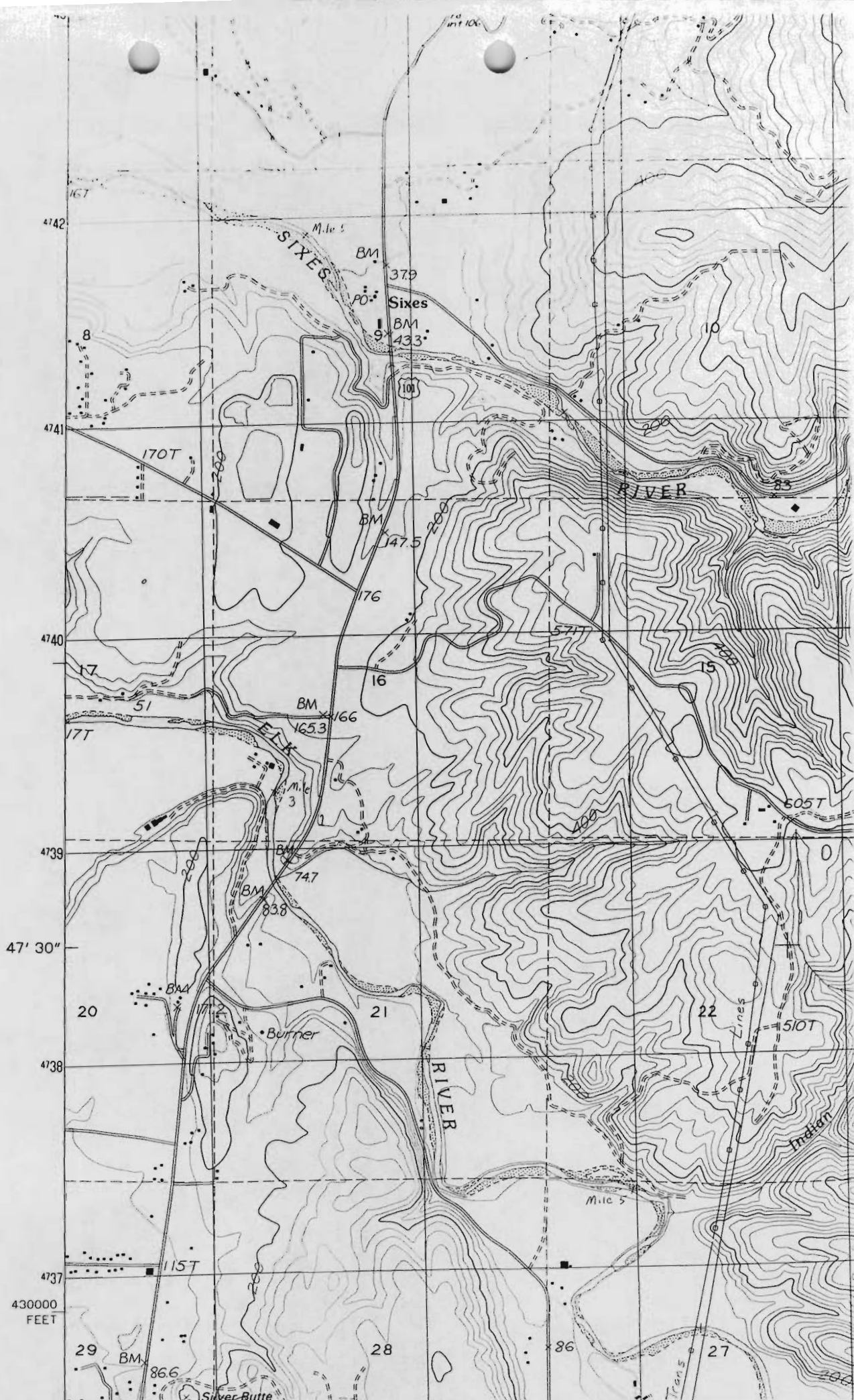

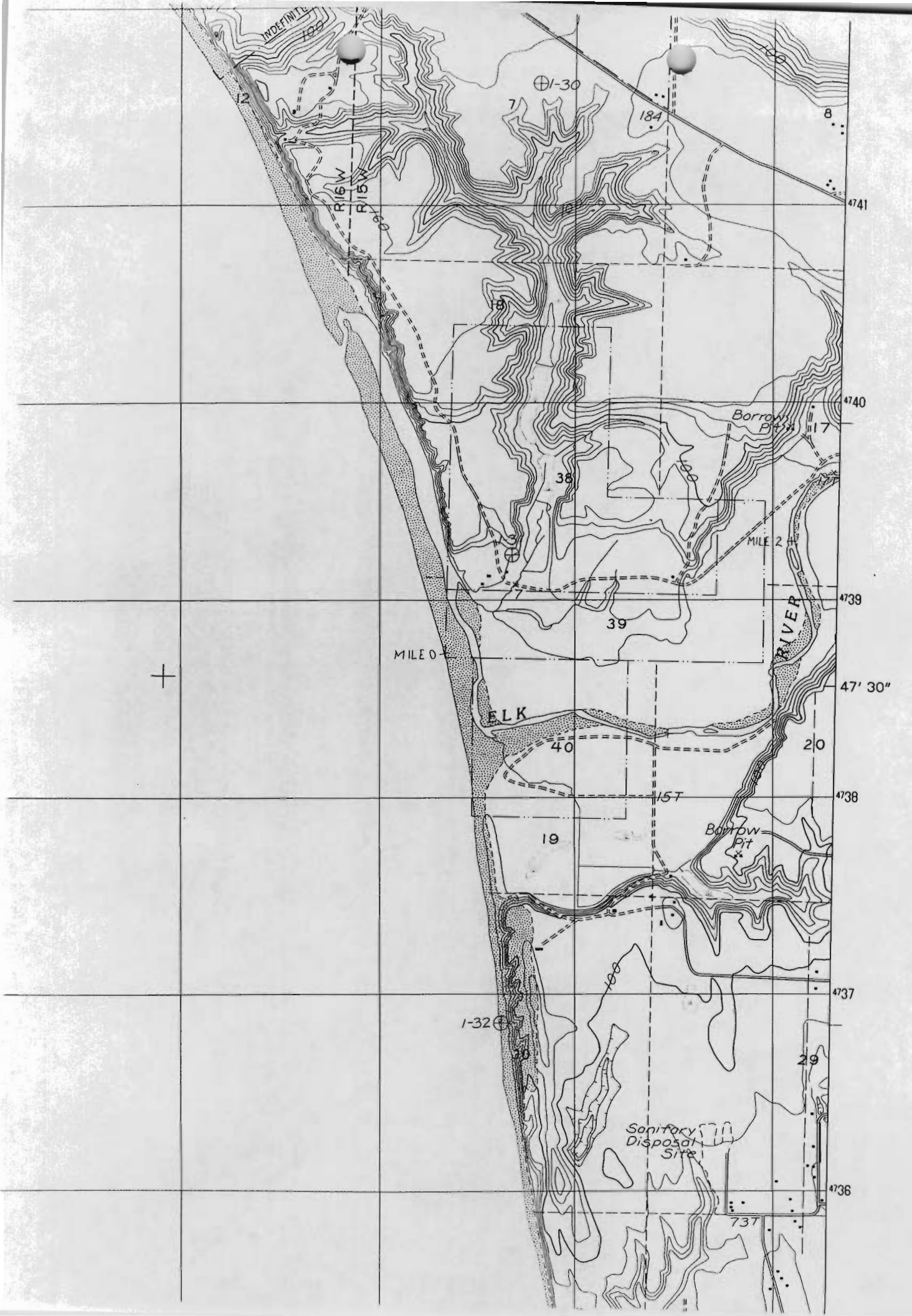


