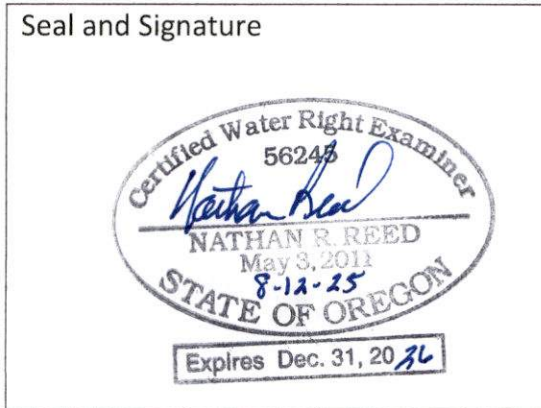

At fish screened POD a 0.5 Hp submersible pump delivers water via a 1-inch ABS line to the top of the bank, where a quick connection is converted to buried 1-inch galvanized pipe southward to a buried 1,500-gallon ~~fiberglass~~ ^{CONCRETE} tank. A secondary 0.5 Hp submersible pump delivers water to whole household use via filtration and pressure bladder. The flow restrictor is located at the POD pump.

Regarding OWRD permit S-55458, ODFW has determined the fish screen at the point-of-diversion meets current fish protection criteria, and fish bypass devices are not necessary. This approval is contingent on the following: current conditions remain unchanged, screens are installed so effective screen area is submerged during operation, the screen is regularly inspected and maintained to ensure it remains in working order (including debris removal), and the screen is annually inspected when it is not in use.
