Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

## **Application History**

Permit G-15708 was issued by the Department on August 16, 2004. and modified by Permit Amendments T-10641, T-11263, T-12010. Permit G-17506 was issued on October 7, 2016. The most recent extension authorized completion of construction and complete application of water to beneficial use by October 1, 2023. On September 13, 2024, Wood River Improvement District Co. submitted an Application for Extension of Time for Permit G-17506. In accordance with OAR 690-315-0050(2), on June 17, 2025, the Department issued a Proposed Final Order proposing to extend the time to complete construction to October 1, 2027, and the time to fully apply water to beneficial use to October 1, 2027. The protest period closed August 1, 2025, in accordance with OAR 690-315-0060(1). No protest was filed.

## FINDINGS OF FACT

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated June 17, 2025.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may be extended subject to the following conditions:

### LIMITATIONS AND CONDITIONS

#### 1. Permit Amendment Condition

The Permit holder shall submit an Application for Permit Amendment within six months from the date of issuance of the Final Order on this Extension of Time. Failure to submit the required Permit Amendment within six months shall result in the automatic termination of this extension of time. The Permit Amendment shall request authorization of KLAM 59974, KLAM 58286, KLAM 59916, KLAM 59319, KLAM 56638/KLAM 59741, and KLAM 57662 as constructed, at the location the wells are constructed. If any one well listed above cannot be approved by permit amendment, that well shall not be included in the final certificate issued for this water right. If none of the wells listed above, this extension of time shall be terminated, and the permit shall be canceled.

### CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

#### ORDER

The extension of time for Application G-15834, Permit G-17506, therefore, is approved subject to conditions contained herein. The deadline for completing construction is extended from October 1, 2023, to October 1, 2027. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2023, to October 1, 2027.
