

Registration Survey Report for Glenn O. Tarbell & Loren G. Tarbell

INFORMATION:

I met Mr. Loren Tarbell at his father's (Mr. Glenn Tarbell) pond. Mr. Loren Tarbell address is 33807 Tarbell Road, Scappoose, OR 97056 and his telephone number is (503)543-2570. Mr. Tarbell showed me the pond and earthen dam. Mr. Glenn Tarbell's father (Mr. A. H. Tarbell) bought this property with a great deal more farm land in 1908. Glenn was 8 years old at that time. He remembers a pond and dam at this site at the time. The pond may have been the site of a pre-1908 rock pit and the dam was a road fill acrossing the draw at the lower end of the rock pit.

SOURCE:

An unnamed creek which is a tributary of Scappoose Bay.

DIVERSION POINT (Dam Site):

The center of the dam at the upstream crest is South 265 feet & 50 feet East of the Southeast corner of Scott Acres.

USES:

This pond is used for stock watering directly from the pond and for wildlife habitat.

POINT OF BEGINNING:

I found the Northwest & Southwest corners of Lot 3, Block 2, Scott Acres and calculated the position of the Southeast corner of Scott Acres.

THE DAM:

The dam is an old earthen fill dam 105 feet long and about 20 feet wide. It is nearly flat from end to end and from 1.1 feet to 1.5 feet above the water level in the pond.


The Dam continued...

There is an earthen spillway across both ends of the dam. There is little sign of erosion at either spillway. I visited the dam site on Dec. 1, 1993 after several days of rain. The water level in the pond was the same as it was on May 13, 1993 and there was very little water going over the spillways. Elevations were shot with a theadolite & EDM on the dam centerline and both spillways.

There is no outlet conduit or structure.

There is no apparent weaknesses of this dam. I see no seepage zones or other defects. The dam is most likely more that 50 years old and is well settled and water tight by this time.

The Registration Survey and Inspection was completed by me on December 10, 1993 and the facts contained in this report and accompanying map are correct to the best of my knowledge.






