**PRE-1909 VESTED WATER RIGHTS

**INFORMATION:**

I met Ray Austin on the site. He showed me the location of the Points of Diversions (P.O.D.'s), the storage tank, the waterlines, and the place of use. This site report and map are to accompany the Austin's Pre-1909 Vested Water Right Claim per file #SWR-481.

**SURVEY TIES:**

I found the south one-quarter corner of Section 25, which is a 3/4" iron pipe set by Stephens and replaced by myself per Coos County Survey Map #5-A-44. I used a hand compass, clinometer, and a rag tape for my measurements.

**SOURCES:**

P.O.D. #1 is the primary source. P.O.D. #2 and #3 are supplemental sources. P.O.D. #2 and #3 are used when the unnamed stream flows are at a minimum.

**DIVERSION POINTS:**

P.O.D. #1 and #2 are 1-1/2" ABS pipes covered with a screen held down by a rock. P.O.D. #3 is a 1-1/2" ABS pipe located in a 3 gallon bucket with a screen on top.

**MOTOR/PUMP:**

Complete gravity system.

**PIPE:**

There is 1,200 feet of 1-1/2" ABS pipe which meanders along the unnamed stream and delivers water to a 500 gallon storage tank. There is 1,100 feet of 1" ABS pipe which delivers water from the storage tank to the place of use.

**USES:**

P.O.D. #1, #2 and #3 are all used as a domestic water supply plus 1/4 acre of lawn and garden irrigation.

**HEAD:**

P.O.D. #1 delivers 50 feet of head to the storage tank.  
P.O.D. #2 delivers 90 feet of head to the storage tank.  
P.O.D. #3 delivers 10 feet of head to the storage tank.  
The storage tank delivers 42 feet of head to the homesite.

**SYSTEM CAPACITY:**

See attached.

This final proof survey and inspection of use per file # SWR-481 was completed by me on April 18, 1993, and the facts contained in this report and accompanying final proof map are correct to the best of my knowledge.



We, Ray Austin and Dollie Austin, agree to the findings of the CWRE and do submit this site report and map as our Claim of Beneficial Use of the water as per our Pre-1909 Vested Water Right Claim per file #SWR-481.

P.O.D. #1, #2, & #3 can deliver from  $0.30 \text{ ft}^3/\text{sec}$  to  $0.34 \text{ ft}^3/\text{sec}$  to the storage tank. The outlet of the storage tank is only 1" ABS pipe. This outlet will be the controlling factor in the systems capacity.

Outlet to place of use:

$$1" \text{ ABS pipe } \Rightarrow n = 0.011$$

$$S = 42' / 1100' = 0.0382 \text{ ft/ft}$$

$$R_h = R/2 = 0.0417 \text{ ft}$$

$$A = \pi r^2 = 0.0218 \text{ ft}^2$$

$$Q = VA = \frac{1.486}{0.011} (0.0417)^{2/3} (0.0382)^{1/2} (0.0218)$$
$$= 0.07 \text{ ft}^3/\text{sec}$$

$\therefore$  The system capacity is  $0.07 \text{ ft}^3/\text{sec}$  and the amount being applied for is  $0.01 \text{ ft}^3/\text{sec}$ .




Dear DOLLIE AUSTIN,



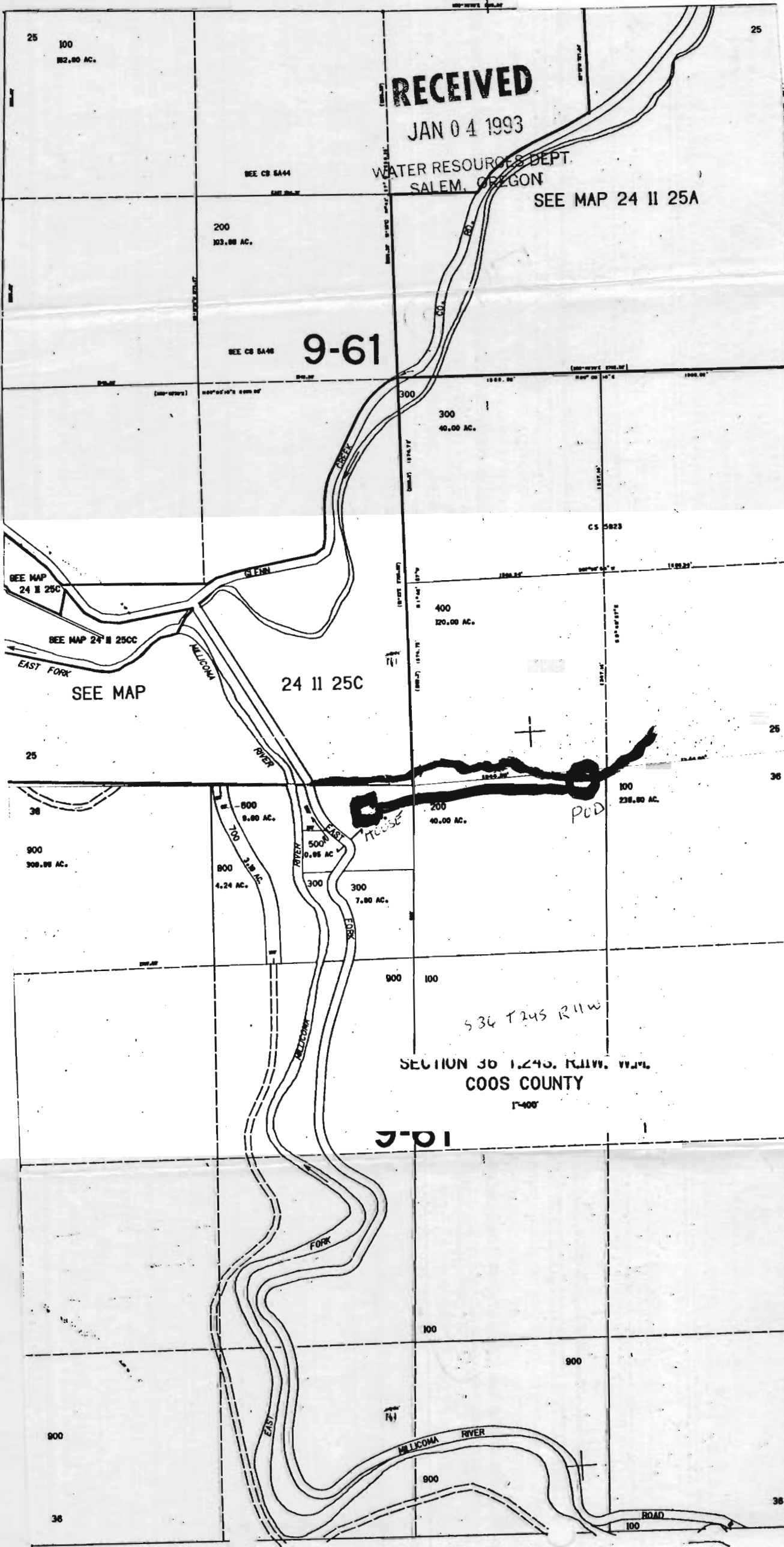
