

A fished screened intake at the re-diversion draws contracted Galesville stored water via 2-inch rubber hose intake through 8 Hp Honda portable gas pump and out 2-inch ABS line, through a meter, to a drainage crossing where the pipeline passes under the road via a culvert to the POU. POU uses two sets of K-line irrigation pods, a 5-pod & 4-pod.

Regarding OWRD permit S-55086, ODFW has determined the fish screen at the point-of-diversion (43.555201, -123.558654) meets current fish protection criteria, and fish bypass devices are not necessary. This approval is contingent on the following: current conditions remain unchanged, screens are installed so effective screen area is submerged during operation, the screen is regularly inspected and maintained to ensure it remains in working order (including debris removal), and the screen is annually inspected when it is not in use.
